## 1 Introduction

## 1.1 Historical Background

The Exportable Crop Survey is a collaborative effort of the National Bureau of Statistics (NBS), Central Bank of Nigeria (CBN), Federal Ministry of Agriculture & Rural Development (FMA&RD) and Federal Ministry of Trade and Investment (FMT&I).

The eighth and ninth editions were combined due to funding challenges faced by the Technical Committee of the Consultative Committee on Agricultural Export Commodity Statistics (CCAECS).

It is an effort geared towards making data available on these supposedly exportable crops for policy makers, researchers and investors. The survey is household-based.

The survey covered the following fourteen crops: Cashew, Cocoa, Coffee, Cotton, Garlic, Ginger, Gum Arabic, Kola nut, Oil Palm, Rubber, Sesame seed (Beni seed), Shea nut, Sugarcane and Tea.

## 1.2 Objectives of the Survey

The major objectives of the survey include:

- To ascertain the spread of the cultivation of each of the fourteen exportable crops within Nigeria in terms of area cultivated by State;
- ii. To provide a national basic data series on exportable agricultural commodities;
- iii. To provide structural data on exportable agricultural commodities in Nigeria;
- iv. To obtain socio-economic data and demographic characteristics of holders within households; and
- v. To provide production estimates at national and state levels.

#### 1.3 Definitional Issues

Exportable agricultural commodity is defined as crops which are currently grown in Nigeria and have export potential.

An agricultural exportable commodity can also be the product of any exportable crop. For example, palm oil and palm kernel are two bi-products of oil palm with export potential.

A holding is the total land area devoted to the cultivation of any of the 14 listed exportable crops.

## 1.4 Sample Achieved

Out of the expected 19,200 households, 19,047 households were covered i.e. 99.2 per cent of the households were studied. On national basis, the survey achieved a response rate of 100 per cent at Enumeration Areas (EAs) level.

## 2 Survey Methodology

## 2.1 Justification

Agricultural Exportable Commodity Statistics Survey is an annual survey which is in line with the mandate given to the Consultative Committee on Agricultural Export Commodity Statistics by the Federal Executive Council. This has helped to expose areas of comparative advantage of all 36 states of Nigeria and Federal Capital Territory (FCT) that cultivate the fourteen identified crops. It also serves as a pointer to states where these crops can easily be found in case of future surveys in the country.

## 2.2 Sample Design

## 2.2.1 Coverage

The survey covered farming households involved in any of the selected exportable crops in the 36 states of the Federation and the Federal Capital Territory (FCT). Allocation of sample in States varied based on the number of exportable crops grown in the state as well as on the intensity of cultivation.

#### 2.2.2 Scope

The scope for data collected was as follows:

- Access to land by type of tenure
- Area cultivated under each crop
- Production in terms of output of each crop
- Use of farm inputs: fertilizer, pesticides and seedlings
- Access to credit facilities
- Employment
- Market channels
- Farm gate and open market prices
- Consumption from own-production
- Transportation and storage
- Use and access to farm implements.

## 2.2.3 Sampling Frame

The first frame was the list of EAs demarcated by the National Population Commission for the 2006 Population and Housing Census.

## 2.2.4 Sample Design

A two-stage cluster sample design was adopted in each state; EAs formed the first stage while Households (HHs) formed the second stage.

## 2.2.5 Sample Size

1,920 EAs were sampled nationwide with 10 HHs selected from each EA, which brought the total number of households covered in the survey to 19,200. Where there were 10 or less farming households, no selection was required and all available households were studied.

## 2.2.6 Reporting Domain

The reporting domain was the State and the aggregates of states data produced the national estimates.

## 2.3 Organisation of Survey

## 2.3.1 Training

Prior to the commencement of field work, three levels of training were conducted. The first level training, Training of the Trainers (TOT), was conducted at Central Bank of Nigeria Headquarters, Abuja. The second level training took place in the six geopolitical zones of the Federation. In the second level training, 117 participants comprising Zonal Controllers, State Officers and Field Officers of the National Bureau of Statistics were trained.

The third level training took place in each of the 36 State capitals and FCT where a total of five hundred and fifty five (555) enumerators and one hundred and eighty five (185) supervisors of the National Bureau of Statistics were trained.

## 2.3.2 Data Collection Strategy

The NBS permanent field staff carried out the data collection. The field staff included enumerators and supervisors while the field coordinators comprised the State Officers and Zonal Controllers of NBS. Each State Officer coordinated all the field operations in his/her state, while the Zonal Controllers supervised the states in their zones.

Each household head or a responsible adult in the household gave information about the household visited.

## 2.3.3 Field Organisation

Ten (10) Exportable crop Farming Households (EFHHs) were selected for coverage. Thereafter, the enumerators administered the holding questionnaire(s) to all qualified agricultural exportable commodity farmers in each of the selected EAs. The exercise lasted two weeks. Through this exercise, relevant information on production, processing, market channels, credit facilities, farm inputs and other agronomic indicators were obtained from the farmers.

## 2.3.4 Supervision/Quality Check

In order to ensure high quality data, a two-phase quality check exercise was put in place. During each phase, monitoring officers skim-checked and spot-checked ten listing forms and ten selected holding questionnaires in the selected EAs in each State and FCT. Farmers were randomly selected and visited on their farms to authenticate the data recorded by enumerators.

## 2.3.5 Data Retrieval/Storage

The retrieved questionnaires were submitted at NBS local government sub-offices. Subsequently, the questionnaires were batched according to EAs and taken to the NBS state offices and finally to the zonal headquarters at Ibadan, Enugu, Calabar, Gombe, Kaduna, and Jos.

## 2.3.6 Data Processing/Analysis

The completed questionnaires were collated and edited manually before data entry operation was carried out by the NBS staff in the six designated NBS zonal headquarters.

Computer data editing, table generation and analysis were carried out by the NBS staff at NBS headquarters, Abuja. Report writing was carried out by the Technical Committee of the Consultative Committee on Agricultural Export Commodity Statistics (CCAECS).

## 3 SURVEY RESULTS

## 3.1 Distribution of Holders by Gender and State

Table 3.1 shows that a total of 7,024,322 holders who cultivated any of the 14 exportable agricultural crops were covered all over the federation for the 2011/2012 farming seasons. Disaggregating by gender shows a total of 6,318,182 (89.94 per cent) male holders while the female holders were 706,140 (10.06 per cent).

By gender, Kano State had the highest male holders of 674,535 (10.68 per cent) while Bayelsa had the lowest figure of 25,665 (0.41 percent).

For female holders across the states, Enugu State topped the list with 63,152 (8.94 per cent) while Sokoto State had the least figure 238 (0.03 per cent).




Figure 1 Distribution of Holders by Gender - National

# 3.2 Funds Committed to 14 Exportable Agricultural Crop - farming by State and source, 2011/2012

Table 3.2 depicts the sources of funds committed to exportable agricultural crops in 2011/2012 survey year. The sources are: "Own fund"; "Friends/Relations"; "Community Bank"; "Bank of Agriculture"; "Commercial Bank"; "Cooperative Society"; "Local Money Lender"; and "Micro Institution".

A total of \$\frac{1}{4}\$ 211.55 billion was committed to exportable crop farming activities during the survey period. Of which "Own fund" led the list with \$\frac{1}{4}\$134.19 billion (63.44 per

cent), followed by "Micro Credit Institutions" with \(\frac{\pmathbb{4}}{36.84}\) billion (17.42 per cent) while "Community Bank" recorded the lowest amount of \(\frac{\pmathbb{4}}{1.29}\) billion (0.61 percent).


#### 3.2.1 Own Fund

Own fund is referred to as personal funds committed to any of the 14 exportable crop farming activities by a holder. Own fund amounted to \(\frac{1}{2}\)134.19 billion representing (63.44 per cent) of the total fund committed. Disaggregating the own fund into states, Kaduna State recorded the highest with \(\frac{1}{2}\)9.51 billion followed by Kano State, \(\frac{1}{2}\)9.45 billion while Ekiti had the lowest amount of \(\frac{1}{2}\)0.61 billion.

#### 3.2.2 Institutional Sources

Funds committed to 14 exportable crop farming through institutional sources were as follows: Cooperative Bank contributed \$\frac{1}{2.61}\$ billion; Bank of Agriculture \$\frac{1}{2.04}\$ billion; Commercial banks \$\frac{1}{4.43}\$ billion; and Community Bank \$\frac{1}{4.29}\$ billion.

## 3.3 Distribution of holders by age group and by State, 2011/2012

Table 3.3 reveals that holders within the ages 30 - 49 years had the highest percentage of 47.99, while the age group 15 - 29 had the lowest percentage of 5.19.




Figure 3 Distribution of Holders by Age Group - National

# 3.4 Distribution of holders by use of improved seed/seedling by State, 2011/2012

Table 3.4 shows the distribution of holders that reported the use of improved seed and/or seedling. A total of 984,235 reported the use of improved seed/seedling, with Kano State reporting the highest number of users 168,138 followed by Katsina State with 123,006. The table shows that Niger State did not report the use of improved seed/seedling. Lagos state reported the least number of holders that used improved seed/seedling with 41.

## 3.5 Estimated area cultivated and production of crops by States for 2011/2012

#### 3.5.1 Cashew

The table reveals 27 States and the FCT planted cashew on a total land area of 120.17 hectares<sup>1</sup>. Kwara State planted the largest hectares of land of 31.49 hectares followed by Imo State with 11.86 hectares. The least areas planted were recorded in Rivers and Akwa Ibom States with 0.01 hectares and 0.55 hectares respectively.

The total production nationwide was 93.29<sup>2</sup> metric tonnes with Kwara State contributing 38.98 metric tonnes. Imo State produced the second largest output with 8.48 metric tonnes. The least productions were found in Rivers State with 0.01metric tonnes and 0.14 metric tonnes in Akwa Ibom State.

#### 3.5.2 Cocoa

The table shows that cocoa was cultivated in 18 States on a total land area of 1,363.60 hectares. Cross River State cultivated the largest land with 327.91 hectares followed by Ondo State with 321.97 hectares. The least cultivated land areas were 0.04 hectares by Imo State and 0.18 hectares by Rivers State.

The total production by the 18 States was 370.01 metric tonnes, with Ondo State contributing the highest with 92.22 metric tonnes followed by Osun State with 74.10 metric tonnes. The least production was 0.01 metric tonnes by Imo State.

#### 3.5.3 Cotton

The table indicates that 18 States produced cotton on a total land area of 399.87 hectares. Zamfara State cultivated the largest land area with 92.62 hectares followed by Katsina State with 75.91 hectares. The least cultivated land areas were Ekiti State 0.07 hectares and Ondo State 0.10 hectares.

The national production figure for cotton was 533.31 metric tonnes out of which Zamfara State produced the highest with 135.56 metric tonnes. The second largest output was 116.61 metric tonnes by Katsina State while the least production was 0.05 metric tonnes by Ekiti State.

#### 3.5.4 Coffee

According to the table, 11 States produced coffee on a total land area of 54.34 hectares. Kogi State cultivated the largest land area with 8.99 hectares (16.54%). The least cultivated land areas were Abia State 0.83 hectares (1.53%).

The total output for coffee nationwide was 32.91 metric tonnes. Taraba State had the highest output with 6.60 metric tonnes. The least output was 0.60 metric tonnes by Abia State.

#### 3.5.5 Garlic

The table reveals that 11 States produced garlic nationwide in the period under review in an estimated land area of 30.49 hectares. Sokoto State cultivated the largest area of land 9.11 hectares (29.88%) The least cultivated land areas were Kaduna State with 0.12 hectares.

National production figure for garlic was 150.12('000) metric tonnes. Sokoto State produced the highest quantity with 39.41 metric tonnes. The least output on garlic was from Kaduna State with 0.09 metric tonnes.

## 3.5.6 Ginger

According to the table, 15 States and the FCT Abuja cultivated ginger nationwide on an estimated total land area of 49.60. Kaduna State cultivated the largest land area with 13.30 hectares. The least cultivated land areas were FCT Abuja with 0.27 hectares.

The total production estimate for ginger nationwide was 167.29 metric tonnes. Kaduna State produced the highest quantity 43.14 metric tonnes followed by Benue State with 34.43 metric tonnes. The least output for ginger was 0.35 metric tonnes.

#### 3.5.7 Gum Arabic

The table reveals that gum arabic was found in 9 States on an estimated total land area of 20.20('000) hectares. Yobe State has the largest area of land with 4.25('000) hectares (21.04%). The least land areas were Katsina State with 0.43('000) hectares.

An estimated 23.04 metric tonnes of gum arabic was produced nationwide. Yobe State recorded the highest with 8.50 metric tonnes. The least output of gum Arabic was from Katsina State with 0.59 metric tonnes.

#### 3.5.8 Kolanut

The table shows that 19 States cultivated kolanut in a total land area of 274.37 hectares. Ondo State cultivated the largest land area with 77.48 hectares. The least cultivated land area for kolanut was Cross River State 0.02 hectares.

The national output on kolanut was 174.23 metric tonnes, Ogun State produced the highest with 51.46 metric tonnes. The least output on Kolanut was from Niger State with 0.02 metric tonnes.

#### 3.5.9 Oil Palm

The table shows that 25 States and the FCT cultivated 1,724.23 hectares of land nationwide for oil palm. The largest land area cultivated was 172.82 hectares by Akwa-Ibom State. The least cultivated land areas were FCT 0.78 hectares and Adamawa State 0.80 hectares.

Total production figure for palm oil was 1,331.53 metric tonnes out of which Akwalbom State produced the largest quantity 135.82 metric tonnes. The least output on oil palm was from the FCT with 0.17 metric tonnes and Adamawa State with 0.20 metric tonnes.

#### 3.5.10 Rubber

From the table in view, 10 States cultivated rubber with a total land area of 65.13 hectares out of which Delta State cultivated the highest with 19.45 hectares. The least cultivated land area was Kogi State with 0.28 hectares.

The total output for rubber was 48.02 metric tonnes. Delta State produced the largest quantity with 15.95 metric tonnes. The least production on rubber was from Kogi State with 0.17 metric tonnes.

#### 3.5.11 Shea Nut

The table indicates that shea nut was found in 19 States and the FCT in an estimated total land area of 334.36('000) hectares. Jigawa State cultivated the largest land area with 35.95 hectares. The least land areas were Nasarawa State with 1.02 hectares.

The total production of shea nuts was 336.39 metric tonnes out of which Kaduna State produced the highest with 35.49 metric tonnes. The estimated least output of shea nut was from Nasarawa State with 1.09 metric tonnes.

## 3.5.12 Sesame Seed (Beniseed)

The table indicates that 17 States and the FCT Abuja cultivated beniseed nationwide in a total land area of 302.13 hectares. Jigawa State cultivated the largest land area with 85.79 hectares. The least land areas cultivated was Sokoto State with 1.00 hectare.

The national production of sesame seed was estimated at 127.60 metric tonnes. Nassarawa State produced the highest quantity with 40.82 metric tonnes. The least output was from Sokoto State with 0.59 metric tonnes.

## 3.5.13 Sugarcane

The table indicates that 28 States and the FCT cultivated 76.38 hectares of land nationwide for the production of sugarcane. Kano State cultivated the largest area of land with 13.27 hectares. The least area of land for sugarcane cultivation was in Enugu State with 0.02 hectares.

The total production nationwide for sugarcane was 1,429.57 metric tonnes. Kano State produced the largest quantity with 401.19 metric tonnes followed by Kaduna State with 197.21 metric tonnes. The least output on sugarcane production was from Lagos State with 0.10 metric tonnes.

#### 3.5.14 Tea

Two states were involved in tea production covering a total land area of 1.67 hectares. Taraba State cultivated the largest land area with 1.31 hectares while Plateau State cultivated 0.36 hectares.

Total output figure for tea was 5.61 metric tonnes. Taraba State produced the highest with 4.17 metric tonnes while Plateau State produced 1.44 metric tonnes of total output.




Figure 4 Estimated Production Levels ('000 metric tonnes) - National 2009-2011

## 3.6 Distribution of holders by mode of Transportation and State, 2011/2012

Table 3.6 shows the Mode of Transportation Facilities which comprises "Truck/Pick up/Van", "Motorcycle", "Bicycle", "Boat/Engine Boat", "Donkey/Camel" and "Head Carrier".

#### 3.6.1 Truck/Pick up/Van

A total of 2,832,121 holders indicated using "Truck\Pick up/Van" for exportable crop farming activities, with the highest number of 394,528 holders was recorded in Kano State, and the lowest number of 5,200 holders was recorded in Bayelsa State.

## 3.6.2 Motorcycle

3,673,439 holders were recorded to have used motorcycles to carry out exportable crop farming activities in 2011/2012 survey year. Kano State had the highest number of 415,365 holders representing whereas the lowest number of 2,756 holders was recorded in Bayelsa State.

## 3.6.3 Bicycle

Nationwide, 1,067,882 holders used bicycles for farming activities. Kano State had the highest number with 143,809 holders, while the lowest number of 268 holders was recorded in Sokoto State.

#### 3.6.4 Boat /Engine Boat

A total of 63,362 holders used boat/engine boat as mode of transportation nationwide. Amongst the states that used this form of transportation, Bayelsa State led the list with 13,549 holders while the lowest number of 208 holders occurred in Edo State.

## 3.6.5 Donkey/Camel

Donkey /Camel as a mode of transportation is commonly used in Northern Nigeria. A total of 713,602 holders used this mode of transportation in 21 states. Across the states, Sokoto State led the list with 185,197 holders while the lowest number of 94 holders occurred in FCT.

#### 3.6.6 Head Carrier

A total of 3,162,608 holders stated head carrying as a mode of transportation. Across the states, Akwa Ibom State recorded the highest number of 181,987 holders whereas Kebbi State recorded the lowest number of 16,391 holders.

#### 3.6.7 Others

Farmers that indicated using "Other mode of transportation" accounted for 586,724 holders nationwide. Among the states, Imo State topped the list with 72,114 holders while the lowest number of 30 holders was recorded in FCT, Abuja.




Figure 5 National Distribution of Holders by Mode of Transportation

## 3.7 Distribution of Holders by Type of Storage Facilities, 2011/2012

Table 3.7 indicated that in Nigeria most storage/processing facilities were sourced through "Self-made" which accounted for 5,645,382 holders; Cooperatives 48,551 holders; and Government 44,912 holders.

#### 3.7.1 Self-made

A total of 5,645,382 holders indicated that their Storage/Processing facilities were "self-made", of which Kano State accounted for the highest number of 608,031 while Imo State recorded the lowest number of 2,921 holders.

#### 3.7.2 Government

A total of 44,912 holders indicated government as their source. Among the states, Bauchi State topped the list with 8,839 holders while Bayelsa State had the lowest number with 30 holders.

#### 3.7.3 Cooperative

A total of 48,551 holders reported cooperative society as a source. Edo State accounted for the highest number of 15,118 holders while Zamfara State had the lowest number with 173 holders.

#### 3.7.4 Others

Apart from sources mentioned in 2011/2012 survey result, a total of 663,780 holders indicated using "Other sources". Anambra State led the list with 117,301 holders (17.67 per cent), while FCT recorded the lowest number with 139 holders.

## 3.8 Distribution of Holders Using Plough Implements, 2011/2012

Table 3.8 reveals that plough implements include "hoe", "cutlass", "animal drawn plough" and "motorized plough". The most common plough implements used among holders (farmers) in the country were hoes and cutlasses which accounted for 5,244,523 and 5,063,181 of the combined total of 12,463,875 ploughing implements.

#### 3.8.1 Hoe

Of the total holders of exportable crops nationwide, 5,244,523 holders used hoes as a plough implement for farming activities. Kano State topped the list with 654,146 holders whereas Bayelsa State recorded the lowest number of 21,812 holders.

#### 3.8.2 Cutlass

A total of 5,063,181 holders used cutlass to plough. Kano had the highest number of 451,020 holders while Imo State recorded the lowest number of 23,950 holders.

## 3.8.3 Animal Drawn Plough

A total of 1,831,765 holders made use of animal drawn plough across the country Kano topped the list with 440,390 holders whereas Oyo State recorded the lowest number of 45 holders.

## 3.8.4 Motorized Plough

A total of 178,310 holders used motorized plough for exportable crop farming activities nationwide. Plateau State had the highest number of 35,284 holders representing while the lowest number of 73 holders was recorded in Enugu State.

## 3.8.5 Other Plough

Apart from the listed plough implements, a total of 146,098 holders used other implements for farming activities. Taraba accounted for the highest number of 21,396 holders while Jigawa State recorded the lowest number of 230 holders.

## 3.9 Distribution of Holders by Annual Sales 2011/2012

Table 3.9 shows the national annual sales range of holders. The holders that recorded sales above one hundred thousand naira had the highest percentage of the distribution 3,085,238. Second highest in annual sales was recorded by holders that made sales of twenty-five thousand but less than fifty thousand Naira, there were 969,223 holders in this category. Holders that made sales of seventy-five thousand but less than one hundred thousand Naira were 902,050 in number. 790,332 holders made sales of fifty thousand but less than seventy-five thousand Naira. 722,937 holders made sales of ten thousand naira but less than twenty-five thousand Naira. Lastly, 342,351 holders made sales less than ten thousand Naira.

## 3.10 Farm Gate Prices in Exportable Crops, 2011/2012

Farm gate price in this survey is defined as the exportable crop produce price fixed by a holder at the farm or nearest market point to the farm excluding the middlemen. This price is valued per kilogram (or litre) in Naira only. The farm gate price covered fourteen exportable crops spread across the 36 states and the FCT as shown in table 3.10.
