Merchandise Trade Growth Declines in Q3 2014:

Decreases in imports and exports leads to a fall in total trade

Total Merchandise Trade


The total value of merchandise trade in Q3 2014 stood at N6,299.7 billion. From the value of N6,659.4 billion recorded in the previous quarter of 2014, this indicates a decrease of N359.6 billion or 5.4%.

The decrease was a result of both a fall in the value of exports and imports in the Third Quarter relative to the Second Quarter; exports declined by N202.7billion or 4.3% to N4,479.5 billion, whilst imports declined by N157.0billion or 7.9% to N1,820.3 billion. The balance of trade therefore remained favourable at N2,659.2 billion.

The value of Crude oil exports stood at N2,931.0 billion, constituting 65.4% of the export total, while the non-crude oil export value of N1,548.5billion made up the remaining 34.6%.

Total trade grew by N641.6billion or 11.3% relative to the N5,658.2 billion recorded in the corresponding quarter of 2013. The year to date total merchandise trade amounted to N18,474.1billion (Table1).

Imports Classified by Standard International Trade Classification and Country of Origin.

Nigeria's imports amounted to a value of N1,820.3 billion in Q3 of 2014. This represents a decrease of N157.0 billion or 7.9% over the N1,977.2 recorded in the previous quarter. In comparison with the N2,084.8 billion of imports recorded in Third Quarter of 2013, the 2014 value revealed a decrease of N264.5 billion or 12.7%. The year to date total imports amounted to a value of N5,343.0 billion, a marginal increase of N13.2 billion or 0.2% from levels recorded in the corresponding period in 2013.

Classified by *SITC*, the quarter-on-quarter decrease in the value of imports was primarily driven by a fall in the value of *Mineral fuel imports* of N100.1billion or 27.2% from the N368.6 billion recorded in Q2 of 2014 to N268.4 recorded in Q3 of 2014. However, significant declines were also recorded in *Machinery and Transport Equipment*, declining by N44.2 billion or 6.8% to a value of N606.4 billion in quarter three and *Chemicals and Related Products*, which declined by N39.5billion or 14.6% to an import value of N231.8 billion in Quarter Three (Table6).

Classified by *Section, Boilers, Machinery and Appliances* accounted for the largest share of imports with a value of N426.8billion or 23.4% of the quarter three total. *Mineral Products* and *Vehicles and Aircraft and Parts* ranked second and third with N278.4billion or 15.3% of the total and N185.9billion or 10.2% of the quarter three total respectively (Table2). Analysis at the product level showed that Motor Spirit recorded the greatest value of imports, contributing N227.8billion or 12.5% of the total imports for Q3, 2014(Product Table).

Third quarter imports classified by *Broad Economic Category* showed that *Industrial Supplies* accounted for the greatest value of imports, at N510.2billion or 28.0% of total imports, followed by *Capital Goods* at N378.9billion or 20.8% of the total, and *Food and Beverages* at N323.8billion or 17.8% of the total (Table7).

Imports grouped by *Continent of Origin* revealed that Asia contributed the highest import value of N779.9billion or 42.8% of the third quarter import total. This was followed by Europe with N676.9billion or 37.2% of the total, The Americas with N266.1billion or 14.6% of the total and Africa with N78.9billion or 4.3% of the total. Out of the total imports from Africa, ECOWAS contributed N15.5billion or 19.7% of the continent's total (Table4).

By *Country of Origin*, China, United States, Belgium, India and Netherlands took the first five positions in terms of the greatest import values with N429.1billion or 23.6% of the total, N183.3billion or 10.1% of the total, N148.4billion or 8.2% of the total, N106.5billion or 5.9% of the total and N94.1billion or 5.2% of the total respectively (Country Table).


Exports Classified by Standard International Trade Classification and Country of Destination.

The value of Nigeria's export trade stood at N4, 479.5billion in the Third Quarter of 2014. In comparison with N4,682.2billion recorded in Q2 of 2014, exports declined by N202.7billion or 4.3%. Further comparison with Q3 of 2013 showed an increase of N906.1billion or 25.4% from the recorded value of N3,573.4 billion (Table1). The year to date exports totalled N13,131.1 billion, a N2,362.7 billion or 21.9% increase relative to last year.


Exports classified by *Section* showed that Mineral Products contributed the greatest value of N4,340.4 billion or 96.9% of the total (Table3). At the product level, aside from Crude oil, *Liquefied Natural Gas* contributed significantly to the total export value in the third quarter of 2014, with N284.7billion or 6.4% of the total export value recorded in the quarter.


By *Region of Destination*, Europe recorded the greatest value of exports with N 1,742.1billion or 38.9% of the total. This was followed by Asia, Africa and The Americas with N1,416.3 or 31.6% of the total, N672.1 billion or 15.0% of the total and N474.3 billion or 10.6% of the total respectively. ECOWAS contributed N376.0billion or 55.9% of total exports to the African continent.

Exports ranked by *Country of Destination* showed that India took the first place with an export value of N685.0billion or 15.3% of the third quarter total. Spain ranked second with N393.3billion or 8.8% of the total, followed by Netherlands with N374.2 billion or 8.4% of the total, Brazil with N238.6billion 5.3% of the total and South Africa N233.7billion or 5.2% of the total for Q3 of 2014 (Country table)



Methodology

The National Bureau of Statistics publishes this Trade statistics report quarterly. Trade statistics compilation by NBS is largely from secondary data sources.

Data Sources:

The Nigerian Customs through the Nigeria Integrated Customs Information System, Nigerian National Petroleum Corporation, Nigeria Liquefied Natural Gas Company, and Petroleum Products Price Regulatory Agency and Central Bank of Nigeria.

Validation & Quality Assurance:

After collecting data from the above sources, it is verified for outliers, Data validation is undertaken through a sample of the various Nigerian Customs outposts in Nigeria. Weight harmonization is carried out through the various entry posts of imports and exports in Nigeria.

Processing/Analysis:

Data processing is done using the Global Eurotrace software and the processed data is banked in the trade database. We use the Harmonised system (HS), Broad economic category (BEC) and Standard International Trade Classification (SITC) to categorize trade items.

Crude Oil Estimation:

The crude oil estimates for the compilation of the 3rd quarter 2014 Foreign Trade Statistics Report were based on the Federation Accounts Allocation Committee (FAAC) Report for the months of July, August and September 2014 on the Nigerian National Petroleum Corporation (NNPC) lifting, while Joint Venture (JVC) partners lifting were predicated on the percentage share of the total in the previous quarter. Again, employing seasonality assumptions, lifting by destinations were based on the developments/directions in the third quarter of year 2013.
