Executive Summary

Registered products 2016 data revealed that 4,296 applications were received for new products registration, 7,679 products were presented for registration approval, 7,444 products were granted registration; 235 products registration were rejected and Zero number was withdrawn while fake and sub-standard products worth 21,035,000,000 were impounded during the year.

Data on imported products registered in the year under review reflected that 3,236 applications were received for new products registration, 2,262 products were presented for registration approval, 2,033 products were granted registration and 229 products registration were rejected.

Similarly, data on locally made products registered in the year under review reflected that 1,060 applications were received for new products registration, 5,417 products were presented for registration approval, 5,411 products were granted registration and 6 products registration were rejected.








Imported – New Registration Applications Received, Products Presented for Registration Approval, Products Granted Registration and Products Registration Rejected










New Registration Applications Received for Total (Imported & Local) Products








Total (Local & Imported) Products Presented for Registration Approval








Total (Imported & Local) Products Granted Registration






