Key Highlights:

NIGERIA'S TOTAL MERCHANDISE TRADE IN Q2, 2023 ROSE SLIGHTLY DUE TO AN INCREASE IN EXPORT AND IMPORT TRADE RESULTING IN AN IMPROVED TRADE BALANCE

In the second quarter of 2023, Nigeria's total trade stood at ₦12,741.96 billion, total exports stood at ₦7,015.71 billion and total imports amounted to ₦5,726.25 billion. Total exports increased by 8.15% when compared to the amount recorded in the first quarter of 2023 (₦6,487.04 billion) but declined by 5.20% compared to the corresponding quarter in 2022 (₦7,400.89 billion). Likewise, in the period under review, total imports increased by 2.99% compared to the value recorded in the first quarter of 2023 (₦5,559.88 billion) but declined by 10.37% when compared to the value recorded in the corresponding quarter of 2022 (₦6,388.51 billion).

The value of Re-exports in the quarter under review stood at ₦91.44 billion representing 1.30% of total exports. Data available shows that the top five re-export destinations were Cameroon, Spain, the Czech Republic, the United Kingdom, and The Netherlands. The most re-exported commodity was 'Other turbines for marine propulsion with ₦41.24 billion, this was followed by 'Mech. propelled vessels for the transport of goods, gross tonnage not specified in 8901' valued at ₦10.96 billion, 'Other gas turbines not specified of a power exceeding 5,000 kW' amounting to ₦6.66 billion, Other article of heading 87.84 not specified valued at 4.77 billion, and mechanically propelled vessels for the transport of goods, gross tonnage=< 500 tonnes' valued at ₦4.22 billion.

The top five export destinations in Q2, 2023 were The Netherlands with ₦788.85 billion or 11.24%, the United States of America with ₦718.63 billion or 10.24%, Indonesia with ₦550.18 billion or 7.84%, France with ₦540.73 billion or 7.71% and Spain with ₦504.45 billion or 7.19% of total exports. Altogether, exports to the top five countries amounted to 44.23% of the total value of exports. The largest export value in the second quarter of 2023 was 'Petroleum oils and oils obtained from bituminous minerals, crude' with ₦5,586.29 billion representing 79.63% this was followed by 'Natural gas, liquefied' with ₦639.37 billion accounting for 9.11%, and 'Urea, whether or not in aqueous solution' with ₦81.21 billion or 1.16% of total exports.

In terms of Imports (CIF), In the second quarter of 2023, the top five partner countries origin of imports to Nigeria were China (₦1,269.41 billion or 22.17%), the United States of America (₦921.45 billion or 16.09%), Belgium (₦460.43 billion or 8.04%), India (₦417.77 billion or 7.30%) and The Netherlands (₦369.69 billion or 6.46%). The values of imports from the top five countries amounted to ₦3,438.76 billion representing a share of 60.05% of total imports. While the commodities with the largest values of imported products were 'Motor Spirit Ordinary' (₦1,230.95 billion or 21.50%), 'Used Vehicles, with diesel or semi-diesel engine, of cylinder capacity >2500cc' (₦733.92 billion or 12.82% and 'Gas oil' (₦230.83 billion or 4.03%).

IMPORTS

The value of total imports stood at ₦5,726.25 billion in the second quarter of 2023, this represents an increase of 2.99% compared with the value recorded in Q1, 2023 (₦5,559.88 billion) though it declined by 10.37% against the value recorded in the corresponding quarter of 2022 (₦6,388.51 billion).

- The value of imports of agricultural goods in Q2 2023 stood at ₦454.85 billion. This showed a decrease of 3.51% and 2.07% when compared to the value recorded in Q1 of 2023 (₦471.39 billion) and the corresponding quarter of 2022 (₦464.45 billion) respectively.
- The value of raw material imports stood at ₦567.80 billion in Q2, 2023. This value increased by 2.22% when compared to the value in Q1, 2023 (₦555.47 billion) but declined by 18.43% when compared to the value recorded in Q2, 2022 (₦696.12 billion) respectively.
- The value of solid minerals imports in the second quarter of 2023 stood at ₦31.63 billion. This value was 29.45% lower than the value recorded in Q1, 2023 (₦44.83 billion) and 18.19% lower than the value recorded in Q2, 2022 (₦38.66 billion).



- The value of energy goods imports stood at ₦0.05 billion in Q2, 2023 while the value recorded in the first quarter of 2023 and the corresponding period of 2022 were ₦0.07 billion and ₦0.01 billion respectively.
- The value of imported manufactured goods in the quarter under review stood at ₦3,019.78 billion showing an increase of 26.02% and 9.57% when compared to the value recorded in Q1, 2023 (₦2,396.23 billion) and the value recorded in Q2, 2022 (₦2,756.02 billion) respectively.
- The value of other oil products imports in Q2 2023 stood at ₦1,652.14 billion indicating a decrease of 21.02% and 32.10% from the value recorded in Q1, 2023 (₦2,091.89 billion) and the corresponding quarter of 2022 (₦2,433.27 billion) respectively.

EXPORTS

The value of total exports in Q2, 2023 stood at ₦7,015.71 billion indicating an increase of 8.15% when compared with the value of exports in Q1, 2023 (₦6,487.04 billion) but decreased by 5.20% when compared with the value recorded in the second quarter of 2022 (₦7,400.89 billion).

- The value of agricultural goods exports stood at ₦280.87 billion in Q2, 2023, showing an increase of 0.44% over the value recorded in Q1 2023 (₦279.64 billion) and a rise of 98.12% when compared to the value recorded in Q2, 2022 (₦141.77 billion).
- The value of raw material goods exports in Q2, 2023 was valued at ₦145.62 billion, this represents a decrease of 27.15% and 60.76% when compared to the value recorded in Q1, 2023 (₦199.89 billion) and Q2, 2022 (₦371.10 billion) respectively.
- The value of solid minerals exports in Q2, 2023 was valued at ₦34.09 billion indicating an increase of 31.00% over the value recorded in Q1, 2023 (₦26.02 billion) and a 62.43% increase when compared to the value recorded in the corresponding quarter in 2022 (₦20.99 billion).
- The exports value of energy goods in Q2, 2023 stood at ₦15.96 billion indicating an increase of 2.34% when compared to the value recorded in Q1, 2023 (₦15.59 billion) and declined by 0.60% compared to Q2, 2022 (₦16.05 billion).
- The value of manufactured goods exports was valued at ₦212.14 billion in Q2, 2023. This represents an increase of 61.76% and 77.47% when compared to the value recorded in Q1 2023 (₦131.15 billion) and Q2 2022 (₦119.53 billion) respectively.
- The value of crude oil exports in Q2, 2023 stood at ₦5,586.29 billion indicating an increase of 8.50% compared to the value recorded in Q1, 2023 (₦5,148.58 billion); and though declined by 5.44% when compared to the same period in 2022 (₦5,907.97 billion).
- The value of other oil products exports in Q2, 2023 was ₦740.74 billion, this showed an increase of 7.95% but declined by 10.05% when compared to the value recorded in Q1, 2023 (₦686.17 billion) and the value in the second quarter of 2022 (₦823.48 billion) respectively.




1.0. Overview

Nigeria's total merchandise trade stood at ₦12,741.96 billion in Q2 2023, indicating an increase of 5.77% over the value recorded in Q1 2023 but it declined by 7.60% when compared to the value recorded in Q2 2022. The disaggregation of total trade into exports and imports shows that total exports stood at ₦7,015.71 billion showing an increase of 8.15% over the value recorded in the preceding quarter and a decrease of 5.20% over the corresponding period in the preceding year.

In addition, the data reveals that the share of exports in total trade stood at 55.06% in Q2, 2023. Exports trade in the second quarter of 2023 was dominated by crude oil exports valued at ₦5,586.29 billion which accounted for 79.63% of total exports while non-crude oil exports value stood at ₦1,429.42 billion or 20.37% of total exports of which non-oil products contributed ₦688.68 billion representing 9.82% of total exports. On the other hand, total imports stood at ₦5,726.25 billion in Q2 2023, indicating an increase of 2.99% over the value recorded in the preceding quarter. The value of imports in the quarter under review fell by 10.37% compared to the value recorded in the corresponding period of 2023. Imports trade share of total trade in the second quarter of 2023 accounted for 44.94% of total trade, bringing the trade balance to ₦1,289.46 billion in the period under review.





1.1. Imports Classified by Standard International Trade Classification and Country of Origin

During the second quarter of 2023, total imports were valued at ₦5,726.25 billion accounting for 44.94% of total trade. Imports value increased by 2.99% in Q2, 2023 compared to the value recorded in Q1, 2023 and fell by 10.37% compared to the value in Q2, 2022. Using the Standard International Trade Classification, the top-ranked group import was “machinery and transport equipment” with ₦1,985.45 billion (34.67% of total imports), this was followed by “mineral fuels” with ₦1,651.43 billion (28.84% of total imports) and “food and live animals” with ₦662.38 billion (11.57% of total imports).



Nigeria imported goods mainly from Asia, valued at ₦2,313.23 billion or 40.40% of total imports. This was followed by Europe with ₦1,966.00 billion or 34.33%, America with ₦1,193.69 billion or 20.85%, Africa with ₦237.33 billion or 4.14% and Oceania with ₦16.00 billion or 0.28% in the second quarter of 2023. Imports from ECOWAS countries accounted for ₦52.01 billion or 0.91% of the value of total imports.

By country of origin, imported goods originated mainly from China and were valued at ₦1,269.41 billion, representing 22.17% of total imports. This was followed by the United States with ₦921.45 billion (16.09% of total imports), Belgium with ₦460.43 billion (8.04% of total imports), India with goods imported valued at ₦417.77 billion or 7.30% of total imports, and the Netherlands with ₦369.69 billion (6.46% of total imports).

1.2. Exports Classified by Standard International Trade Classification and Country of Destination

The value of total exports stood at ₦7,015.71 billion in the second quarter of 2023, this accounted for 55.04% of total trade. The value of exports increased in Q2, 2023 by 8.15% above the level recorded in Q1, 2023 and declined by 5.20% when compared to the value recorded in Q2 2022.

Exports by section revealed that Nigeria exported mainly ‘mineral products’ which amounted to ₦6,377.08 billion, or 90.90 of the total export value; followed by ‘Vegetable products’, which were valued at ₦217.13 billion (or 3.09% of the value of total exports) and ‘Base metals and articles of base metals’ worth ₦128.32 billion (1.83% of the value of total exports).


Exports trade by region in Q2, 2023 shows that Nigeria exported most products to Europe with goods valued at ₦3,160.67 billion or 45.05% of total exports, followed by exports to Asia valued at ₦1,728.74




billion (24.64% of total exports), exports to America was valued at ₦1,372.23 billion, (19.56% of total exports) while export to other African countries stood at ₦747.84 billion or 10.66% of total exports of which ₦425.74 billion worth of goods were exported to ECOWAS countries.

The export destination during the quarter under review shows that The Netherlands recorded the highest value at ₦788.85 billion representing 11.24% of total exports. This was followed by the United States of America with ₦718.63 billion or 10.24%, Indonesia with ₦550.18 billion or 7.84%, France with ₦540.73 billion or 7.71%, and Spain with ₦504.45 billion or 7.19%. These five countries collectively accounted for 44.23% of the value of total exports in Q2, 2023.

2.0 Exports and Imports Products Classified by Sectors Q1, 2023


2.1 Agricultural Goods Sector

The value of total trade in agricultural goods in Q2, 2023 stood at ₦735.72 billion of which exports were valued at ₦280.87 billion in Q2 2023. Exports of agricultural goods marginally increased by 0.44% over the value recorded in Q1 2023 (₦279.64 billion) and showed a sharp increase of 98.12% when compared to the value recorded in Q2, 2022 (₦141.77 billion) respectively.

During this quarter, most agricultural products were exported to Asia, valued at ₦202.61 billion, followed by Europe with ₦55.52 billion. Export of agricultural products was dominated by 'Cashew nuts Shelled' valued at ₦57.79 billion followed by 'Cashew nuts in shell,' with ₦55.02 billion and 'Sesamum seeds' with ₦38.32 billion. By direction of trade, 'Cashew nuts Shelled' worth ₦52.53 billion and ₦4.05 billion were exported to Vietnam and India, respectively. Furthermore, 'Cashew nuts in shell' worth ₦34.72 billion and ₦18.83 billion were exported to Vietnam and India respectively, followed by exports of 'Sesamum seeds' worth ₦13.39 billion and ₦5.50 billion to Japan and China, respectively.

On the other hand, total imports of agricultural goods in Q2, 2023 stood at ₦454.85 billion or 7.94% of total imports in Q2, 2023. This is a decrease of 3.51% when compared to the value recorded in Q1, 2023 (₦471.39 billion) and by 2.07% when compared to the value recorded in Q2, 2022 (₦464.45 billion). The major agriculture goods imported in Q2, 2023 included 'Durum wheat (not in seeds)' from Poland with ₦44.80 billion and Lithuania with ₦41.63 billion. This was followed by 'Fractions of Palm oil and its fractions, not fit for human consumption.' from Malaysia valued at ₦19.60 billion.

MAIN AGRICULTURAL EXPORTS IN Q1,2023 (N'MILLION)








2.2 Solid Minerals Sector

The value of total trade in solid minerals goods in Q2, 2023 stood at ₦65.71 billion representing 0.52% of total trade in Q2, 2023 of which solid minerals exports stood at ₦34.09 billion. This shows an increase of 31.00% when compared to the value recorded in Q1, 2023 (₦26.02 billion). It also increased by 62.43% when compared to the corresponding quarter of 2022 (₦20.99 billion). The major exported solid mineral goods were ‘Tin ores and concentrates’ to Malaysia, valued at ₦7.93 billion, followed by ‘Other excluding White cement’ worth ₦4.95 billion to Niger. On the other hand, solid mineral imports were dominated by ‘Plaster’ imported from Turkey worth ₦7.35 billion and Egypt valued at ₦2.20 billion. Other products imported under this category were ‘Gypsum; anhydrite’ from Spain (₦3.60 billion) and Turkey (₦1.96 billion).

2.3 Manufactured Goods Sector

The value of manufactured goods traded in Q2, 2023 stood at ₦3,231.92 billion representing 25.36% of total trade. Of this, the export component accounted for ₦212.14 billion. The major export goods in this category were ‘Other turbines for marine propulsion’ exported to Cameroon in values worth ₦41.24 billion. This was followed by ‘Unwrought aluminium alloys’ valued at ₦22.04 billion and ₦3.14 billion to Japan and China respectively and ‘Cathodes and sections of cathodes’ exported to Japan valued at ₦7.59 billion. Exports by region showed that manufactured goods were mainly exported to Other African countries valued at ₦77.52 billion followed by manufactured goods exported to Asia at ₦71.97 billion and Europe valued at ₦43.96 billion.

Manufactured goods mainly imported were ‘Used Vehicles, with diesel or semi-diesel engine, of cylinder capacity >2500cc’ from the United States and United Arab Emirates valued at ₦721.79 billion, ₦2.12 billion, respectively followed by ‘Parts suitable for use solely or principally Other’ also imported from the Netherlands valued at ₦41.43



billion. Other goods imported in this category were 'Machines for reception, conversion and transmission ... of voice, images or data.' from China ₦55.36 billion and 'Other medicaments not elsewhere specified' from India ₦24.74 billion.

2.4 Raw Material Goods Sector

The value of total trade of raw materials stood at ₦713.42 billion in the second quarter of 2023 of which imports were valued at ₦567.80 billion while exports stood at ₦145.62 billion. During the quarter, 'Urea whether or not in aqueous solution' was exported to the United States at a value of ₦36.15 billion. This was followed by 'Nonmonetary Gold (including gold plated with platinum) in Powder form' exported to Switzerland valued at ₦19.80 billion. In terms of imports, 'Cane sugar specified in Subheading Note 2 to Chapter 17, Meant for sugar refinery' worth ₦111.05 billion was imported from Brazil, this was followed by 'Other lubricating oils meant to be mixed further' imported from the United States valued at ₦9.34 billion, while 'Sheets for veneering (including those of other)' imported from China was valued at ₦20.53 billion.


Trade by Sector (N'billion)

3.0. Trade by Mode of Transport

In the review quarter, most commodities exported out of Nigeria were by sea. Maritime transport accounted for ₦6,941.22 billion or 98.94% of total exports. Air transport accounted for ₦38.37 billion or 0.55%, while Road transport recorded ₦20.16 billion or 0.29%. Likewise, on the import side, maritime transport accounted for ₦5,345.22 billion or 93.35% of the value of total imports, while Air transport accounted for goods valued at ₦339.55 billion or 5.93% while road transport accounted for ₦41.49 billion or 0.72%.

4.0. Trade by Custom Ports and Post

In Q2, 2023, the bulk of export transactions were carried through Apapa Port with goods valued at ₦6,570.56 billion or 93.65% of total exports. This was followed by TIN CAN ISLAND which recorded ₦213.88 billion or 3.05% of total export. In terms of imports, correspondingly, Apapa Port also recorded the highest number of transactions valued at ₦3,649.99 billion or 63.74% of total imports. This was followed by Tin Can Island which accounted for goods valued at ₦704.83 billion or 12.31%, while PortHarcourt (3) Onne handled ₦398.06 billion or 6.95% of total imports.




Methodology

The National Bureau of Statistics publishes this Trade Statistics report on a quarterly basis. Trade Statistics compilation by NBS is largely from secondary data sources.

Data Sources:

The data sources for the compilations include; The Nigerian Customs Service (NCS) through the Nigeria Integrated Customs Information System (NICIS), Nigerian National Petroleum Company (NNPCL), Various companies in the upstream and downstream sectors of the oil industry, Nigerian Midstream and Downstream Petroleum Regulatory Authority (NMDPRA), Nigeria Liquefied Natural Gas Ltd (NLNG), Central Bank of Nigeria (CBN), Angila International Limited, Neroli Technologies Limited, Gojopal Nigeria Limited, Nigerian Export Processing Zone Agency (NEPZA), Oil and Gas Free Zone Agency (OGFZA), Nigerian Electricity Regulatory Commission (NERC), Federal Airports Authority of Nigeria (FAAN), Nigeria Civil Aviation Authority (NCAA) and Nigerian Ports Authority (NPA).

Validation & Quality Assurance:

Once data is collected from the above-stated sources, it is screened and verified for outliers. Data validation is undertaken through a sample of the various Nigerian Customs Service outposts in Nigeria. Weight harmonization is also carried out through the various entry ports in Nigeria.

Processing/Analysis:

Data processing is done using the Global Eurotrace software and the processed data is banked in the trade database. Standard International Trade Classification (SITC) is used to classify and categorize trade items.

Definitions:

- **Domestic exports** – These are goods grown, extracted, or manufactured in Nigeria and are sold in another country.
- **Re-export** – These are goods of foreign origin that entered Nigeria to be consumed but are subsequently sold to another country without any substantial transformation. In other words, they are exported in the same condition as imported.
- **Raw material goods** – This refers to products of agriculture, forestry, fishing, and any other mineral that are in their natural form or which have undergone the minimal transformation required to prepare them for international marketing.
- **Agricultural goods** – These are goods that come from the planting of crops and/or the rearing of animals.
- **Solid minerals** – These are elements found in the earth; and naturally organic substances that are solid like precious stones, kaolin etc.
- **Energy goods** – This only refers to fuel woods in logs, for example, hardwood, charcoal, coniferous wood in chips or particles etc.
- **Manufactured goods** – These are tangible goods created from the conversion of raw materials into consumable or useful products.
- **Other Petroleum products** – This consists of mineral fuels like natural gas, oil, bituminous coal etc.
- **Crude oil** – These are naturally occurring, unrefined petroleum products composed of hydrocarbon deposits and other organic materials.
