Preface

This publication provides data on Quarterly Gross Domestic Product (GDP) estimates for the four quarters of 2022, the annual figure for 2022, the four quarters of 2023 and the annual figure for 2023.

Quarterly National Accounts (QNA) are integrated systems of macroeconomic accounts designed to describe the entire system of production in a nation quarterly. They provide a picture of the current economic status of the economy that is timely and more frequent than that provided by Annual National Accounts (ANA). The key attribute of QNA is that they provide a reasonable level of detail of the economy that helps the government to assess, analyse, and monitor economic growth regularly.

QNA adopts the same concepts, definitions, and structure as ANA. In principle, QNA covers the entire sequence of accounts and balance sheets as reflected in the 2008 System of National Accounts (2008 SNA).

Data for this analysis were obtained from the Quarterly Establishment Survey (QES) conducted by the National Bureau of Statistics (NBS). This series covers major aggregates of quarterly GDP by kind of economic activities at current and constant (2010) prices.

We are grateful to the various agencies and establishments that made their data available as input to the estimates.

Introduction

The National Bureau of Statistics (NBS) has been conducting Establishment Surveys to provide data for the estimation of the Gross Domestic Product (GDP) for the country. In 2008, NBS started to improve the GDP series by conducting Quarterly Establishment Surveys (QES) for the four quarters of each year to provide timely estimates for decisions and policymaking.

In 2018, the National Bureau of Statistics (NBS) conducted the Quarterly Establishment Surveys for the first three quarters of 2018 (Q1-Q3/ 2018), while the fourth quarter survey for 2018 was conducted in the first quarter of 2019. This compilation procedure is carried out to date publishing the Q4 GDP report within the first quarter of the new accounting year. It is important to note that the Bureau maintains a publication date of 45 days after the quarter.

In subsequent sections of this report, emphasis will be given to the composition of GDP in the fourth quarter of 2023, the corresponding quarter of 2022, and the immediate past quarter of 2023 (Q3 2023).



Overview of GDP in Quarter Four 2023

Nigeria's Gross Domestic Product (GDP) grew by **3.46%** (year-on-year) in real terms in the fourth quarter of 2023. This growth rate is lower than the 3.52% recorded in the fourth quarter of 2022 and higher than the third quarter of 2023 growth of 2.54%. The performance of the GDP in the fourth quarter of 2023 was driven mainly by the Services sector, which recorded a growth of 3.98% and contributed 56.55% to the aggregate GDP. The agriculture sector grew by 2.10%, from the growth of 2.05% recorded in the fourth quarter of 2022. The growth of the industry sector was 3.86%, an improvement from -0.94% recorded in the fourth quarter of 2022. In terms of share of the GDP, industry, and the services sectors contributed more to the aggregate GDP in the fourth quarter of 2023 compared to the fourth quarter of 2022. On an annual basis, GDP grew by 2.74% in 2023 relative to 3.10% in 2022.

In the quarter under review, aggregate GDP stood at N65,908,258.59 million in nominal terms. This performance is higher when compared to the fourth quarter of 2022 which recorded aggregate GDP of N56,757,889.95 million, indicating a year-on-year nominal growth of 16.12%. For better clarity, the Nigerian economy has been classified broadly into the oil and non-oil sectors (Pages 5 & 6).




Figure 1: Real GDP Growth




Figure 2: Top 10 Contributing Activities to Real GDP in Q4 2023

The Oil Sector

The nation in the fourth quarter of 2023 recorded an average daily oil production of 1.55 million barrels per day (mbpd), higher than the daily average production of 1.34mbpd recorded in the same quarter of 2022 by 0.21mbpd and higher than the third quarter of 2023 production volume of 1.45 mbpd by 0.10mbpd. 


Figure 3: Crude Oil Output (MBPD)

The real growth of the oil sector was 12.11% (year-on-year) in Q4 2023, indicating an increase of 25.50% points relative to the rate recorded in the corresponding quarter of 2022 (-13.38%). Growth also increased by 12.96% points when compared to Q3 2023 which was -0.85%. On a quarter-on-quarter basis, the oil sector recorded a growth rate of -3.81% in Q4 2023. On an annual basis, the oil sector growth stood at -2.22% in 2023 compared to -19.22% in 2022. The Oil sector contributed 4.70% to the total real GDP in Q4 2023, up from the figure recorded in the corresponding period of 2022 and down from the preceding quarter, where it contributed 4.34% and 5.48% respectively.

The Non-Oil Sector

The non-oil sector grew by 3.07% in real terms during the reference quarter (Q4 2023). This rate was lower by 1.37% points compared to the rate recorded in the same quarter of 2022 and 0.32% points higher than the third quarter of 2023. This sector was driven in the fourth quarter of 2023 mainly by Financial and Insurance (Financial Institutions); Information and Communication (Telecommunication); Agriculture (Crop production); Trade; Construction; Manufacturing (Food, Beverage, and Tobacco) and Real Estate, accounting for positive GDP growth. On an annual basis, the non-oil sector growth in 2023 stood at 3.04% relative to 4.84% recorded in 2022.

In real terms, the non-oil sector contributed 95.30% to the nation's GDP in the fourth quarter of 2023, lower than the share recorded in the fourth quarter of 2022 which was 95.66% and higher than the third quarter of 2023 recorded as 94.52%.





Figure 4: Crude Oil and Non-Oil Growth

CONTRIBUTION OF OIL AND NON-OIL SECTORS






OIL PRODUCTION (MBPD)




CONTRIBUTION TO REAL GDP

Major Economic Sectors: Q4 2023

Mining & Quarrying

The Mining & Quarrying sector consists of Crude Petroleum and Natural Gas, Coal Mining, Metal ore and Quarrying and other Minerals sub-activities. This sector grew nominally by 15.07% (year-on-year) in Q4 2023. Metal Ores exhibited the highest growth rate of all the sub-activities at 27.14%, followed by Crude Petroleum and Natural Gas activity at 22.55%. Crude Petroleum and Natural gas was the main contributor to the sector with a weight of 70.17% in Q4 2023. Comparing Q4 2023's rate of growth relative to Q4 2022 and Q3 2023 growth rates, there was an increase of 16.14% points and a decrease of 16.83% points respectively. The annual growth of the sector stood at 8.92% in 2023 relative to 27.11% in 2022. The Mining & Quarrying sector contributed 4.47% to the overall GDP in the fourth quarter of 2023, lower than the contributions recorded in 2022 fourth quarter at 4.51% and lower than the previous quarter at 8.32%.

In real terms, the Mining and Quarrying sector grew by 8.04% (year-on-year) in the fourth quarter of 2023. Compared to the same quarter of 2022 and the third quarter of 2023, it was higher by 19.43% points and higher by 10.01% points respectively. Quarter- on- quarter, the growth rate recorded was -2.38% during the quarter. In addition, annual growth of the sector in 2023 was -2.84%, higher than -18.16% in 2022. The contribution of Mining and Quarrying to Real GDP in the quarter under review stood at 4.91%, higher than the rate of 4.71% recorded in the corresponding quarter of 2022 and lower than the 5.64% recorded in the third quarter of 2023.




Figure 5: Mining and Quarrying real growth

Agriculture

Four sub-activities make up the Agricultural sector: Crop Production, Livestock, Forestry and Fishing. The sector grew by 14.94% year-on-year in nominal terms in Q4 2023, showing a decrease of 3.74% points from the same quarter of 2022. Looking at the preceding quarter's growth rate of 11.06%, there was an increase of 3.88% points. Crop Production remained the major driver of the sector. This is evident as it accounts for 90.03% of the overall nominal value of the sector in the fourth quarter of 2023.

Quarter-on-quarter growth stood at 1.62% in the fourth quarter of 2023. Agriculture contributed 24.65% to nominal GDP in the fourth quarter of 2023. This figure was lower than the rate recorded in the fourth quarter of 2022 and lower than the third quarter of 2023 which recorded 24.90% and 26.36% respectively.




Figure 6: Agriculture real growth

The agricultural sector in the fourth quarter of 2023 grew by 2.10% (year-on-year) in real terms, an increase of 0.06% points from the corresponding period of 2022, and an increase of 0.81% points from the preceding quarter which recorded a growth rate of 1.30%. It grew on a quarter-on-quarter basis at -0.22%. On an annual basis, the agriculture sector grew by 1.13% in 2023, down from 1.88% in 2022.

However, the sector contributed 26.11% to overall GDP in real terms in Q4 2023, lower than the contribution in the fourth quarter of 2022 and lower than the third quarter of 2023 which stood at 26.46% and 29.31% respectively.

Manufacturing

The Manufacturing sector is comprised of thirteen activities: Oil Refining; Cement; Food, Beverages and Tobacco; Textile, Apparel, and Footwear; Wood and Wood products; Pulp Paper and Paper products; Chemical and Pharmaceutical products; Non-metallic Products, Plastic and Rubber products; Electrical and Electronic; Basic Metal and Iron and Steel; Motor Vehicles and Assembly; and Other Manufacturing.

Nominal GDP growth of the Manufacturing sector in the fourth quarter of 2023 was recorded at 38.06% (year-on-year), 29.20% points higher than the figure recorded in the corresponding period of 2022 (8.86%) and 1.47% points higher than the preceding quarter figure of 36.59%. Quarter-on-quarter, growth of the sector was recorded at 7.70% during the quarter. On an annual basis, the sector grew by 30.93% in 2023 compared to 6.93% in 2022. The contribution of Manufacturing to Nominal GDP in the fourth quarter of 2023 was 16.04%, higher than the figure recorded in the corresponding period of 2022 at 13.49% and lower than the third quarter of 2023 at 16.18%.

Real GDP growth in the manufacturing sector in the fourth quarter of 2023 was 1.38% (year-on-year), lower than the same quarter of 2022 and higher than the preceding quarter by 1.46% points and 0.90% points respectively. The growth rate of the sector on a quarter-on-quarter basis stood at 9.54%. On an annual basis, the sector grew by 1.40% in 2023, lower than 2.45% in 2022. The Real contribution to GDP in the 2023 fourth quarter was 8.23%, lower than the 8.40% recorded in the fourth quarter of 2022 and lower than the 8.42% recorded in the third quarter of 2023.




Figure 7: Manufacturing real growth

Electricity, Gas, Steam and Air Conditioning Supply

The Electricity, Gas, Steam and Air conditioning Supply sector recorded a year-on-year growth of 34.28% in the fourth quarter of 2023. This was 11.87% points higher than the 22.41% growth rate recorded in the corresponding quarter of 2022, and 1.73% points lower than the growth rate of 36.01% recorded in the quarter before. Quarter-on-quarter, the sector recorded a growth rate of 62.41% in Q4 2023. On an annual basis, the sector grew by 35.66% in 2023 relative to 2.88% in 2022. The contribution of Electricity, Gas, Steam and Air Conditioning Supply to Nominal GDP in the fourth quarter of 2023 was 1.26%, higher than the contribution made in the corresponding quarter of 2022 at 1.09% and higher than its contribution of 0.84% in the quarter before.

In real terms, the sector grew by 6.17% in Q4 2023, a decrease from the growth rate of 15.22% recorded in the same quarter of 2022. When compared to the immediate past quarter, there was an increase of 4.26% points from 1.91% recorded. On a quarter-on-quarter, the sector grew at a rate of 62.04%. On an annual basis, the sector grew by 5.56% in 2023 relative to -2.21% in 2022. The contribution of this sector to real GDP in the fourth quarter of 2023 was 0.54%, slightly higher than the 0.53% recorded in Q4 2022. Moreover, the figure in Q4 2023 was higher than the 0.37% recorded in Q3 2023.




Figure 8: Electricity, Gas and Steam real growth

Water Supply, Sewerage, Waste Management and Remediation

This sector grew by 39.14% in nominal terms (year-on-year) in the 2023 fourth quarter, an increase of 18.29% points compared to the rate of 20.86% recorded in the same quarter of 2022. There was also an increase of 13.26% points when compared to the rate recorded in the preceding quarter. Nominal growth quarter-on-quarter was recorded at -4.11%. On an annual basis, the sector grew by 46.78% in 2023, higher than 24.38% in 2022. The Water Supply, Sewerage, Waste Management and Remediation sector contributed 0.29% to nominal GDP in the fourth quarter of 2023, higher than the 0.24% it contributed a year earlier and lower than the 0.33% contributed in the third quarter of 2023.

The real growth rate of the Water Supply, Sewerage, Waste Management and Remediation sector in the fourth quarter of 2023 was recorded at 7.44% (year-on-year), lower by 1.37% points from the rate recorded in the previous year. Relative to the preceding quarter, there was a decrease of 4.49% points. Quarter-on-quarter, the sector grew by -4.41% in real terms. On an annual basis, the sector growth stood at 12.65% in 2023 compared to 13.62% in 2022.

Its contribution to total real GDP was 0.17% in the fourth quarter of 2023, relatively the same with its contribution of 0.17% in the same quarter of the previous year, and lower than the immediate past quarter where it contributed 0.20%.




Figure 9: Water Supply, Sewerage, Waste Management and Remediation real growth

Construction

The Construction sector grew by 2.87% in nominal terms (year-on-year) in the 2023 fourth quarter, a decrease of 14.28% points compared to the rate of 17.14% recorded in the same quarter of 2022. Also, there was a decrease of 0.15% points when compared to the rate recorded in the preceding quarter. Nominal growth quarter-on-quarter was recorded at 15.92%. On an annual basis, the nominal growth of the sector was 18.43% in 2023 relative to 12.72% in 2022. Construction contributed 9.00% to nominal GDP in the fourth quarter of 2023, lower than the 10.16% it contributed a year earlier and higher than the 8.43% contributed to the third quarter of 2023.

The real growth rate of the construction sector in the fourth quarter of 2023 was recorded at 3.70% (year-on-year), lower by 0.11% points from the rate recorded in the previous year. Relative to the preceding quarter, there was a decrease of 0.19% points. Quarter-on-quarter, the sector grew by 15.69% in real terms. On an annual basis, the sector growth stood at 3.57% in 2023 compared to 4.54% in 2022.

Its contribution to total real GDP was 3.47% in the fourth quarter of 2023; relatively same with its contribution of 3.47% in the same quarter of the previous year, and higher than in the immediate past quarter where it contributed 3.36%.




Figure 10: Construction real growth

Trade

In the fourth quarter of 2023, the nominal year-on-year growth rate of Trade stood at 3.36%. This indicates a decrease of 11.45% points when compared to the fourth quarter of 2022 growth rate of 14.82% and 0.27% points higher than the previous quarter's growth rate of 3.10%. The quarter-on-quarter growth rate was 15.45%. On an annual basis, the sector grew by 3.01%, lower than 14.25% in 2022. Trade's contribution to Nominal GDP in the fourth quarter of 2023 was 11.75%, lower than the contribution in the same quarter of the previous year of 13.20%, and higher than the preceding quarter recorded at 11.06%.

In real terms, Trade's year-on-year growth stood at 1.40% in the fourth quarter of 2023, which was 3.15% points lower than the rate recorded in the previous year at 4.54%, and 0.13% points lower than in the preceding quarter at 1.53% growth rate. Quarter-on-quarter growth stood at 14.27%. This growth was higher than the quarter-on-quarter growth recorded in the third quarter of 2023 at -0.74%. On an annual basis, trade grew by 1.66% in 2023 compared to 5.13% in 2022. Trade's contribution to GDP was 15.50%, lower than the 15.82% it represented in the previous year, and higher than the 15.19% recorded in the 2023 third quarter.

Accommodation and Food Services

In nominal terms, Accommodation and Food Services grew by 15.11% year -on- year in 2023 fourth quarter. This represents a decrease of 10.46% points relative to the same quarter of 2022 when the growth rate was 25.56%. Growth was higher than in the preceding quarter by 8.09% points when growth was 7.02%. Quarter-on-quarter growth stood at 23.58%. On an annual basis, the sector grew by 13.05%, lower than 18.11% in 2022. Accommodation and Food Services contribution to nominal GDP stood at 0.95% in the fourth quarter of 2023, lower than the figure recorded in the previous year and higher than the third quarter of 2023 contribution recorded at 0.96% and 0.83% respectively.

The real year-on-year growth rate for this sector in the 2023 fourth quarter stood at 3.28%, lower by 1.84% points from 5.12% recorded in the previous year. Relative to the preceding quarter, the growth rate was 0.29% points lower than the 3.57% recorded. Quarter-on-quarter, real growth was 22.78%. On an annual basis, the sector grew by 3.46% relative to 4.22% in 2022. The sector in the fourth quarter of 2023 represented 0.79% of the real GDP, which was relatively same with the contribution of 0.79% recorded in the fourth quarter of 2022 and higher than the third quarter of 2023 contribution of 0.72%.

Transportation and Storage

Six activities make up the Transportation and Storage sector: Road Transport; Rail Transport and Pipelines; Water Transport; Air Transport; Transport Services; and Post and Courier Services.

The sector grew by -19.05% in nominal terms in the fourth quarter of 2023 (year-on-year). This rate was lower relative to the figure of 33.67% recorded for the corresponding quarter of 2022 and higher than the -28.57% in the previous quarter. Five of six sub-activities under the Transport and Storage industry recorded positive growth rates in the fourth quarter of 2023. Quarter-on-quarter growth stood at 51.87%. On an annual basis, the sector grew by -21.94%, lower than 27.06% in 2022. Transport activities contributed 1.62% to Nominal GDP in Q4 2023, a decrease from the 2.33% recorded in the corresponding period of 2022, and higher than the 1.16% recorded in the third quarter of 2023.

In real terms, the Transportation and Storage sector grew by -29.00% in Q4 2023. This rate represents a decrease of 29.78% points compared to the same quarter of the previous year and an increase of 6.85% points relative to the preceding quarter. Quarter-on-quarter, growth was 46.85%. On an annual basis, the sector grew by -30.17%, lower than 15.20% in 2022. The contribution of the sector to real GDP in Q4 of 2023 was 1.10%, a fall from 1.61% recorded in the preceding year and higher than 0.84% recorded in the third quarter of 2023.

Information & Communication

The Information and Communication sector is composed of the four activities of Telecommunications and Information Services; Publishing; Motion Picture, Sound Recording and Music Production; and Broadcasting.

In nominal terms, in the fourth quarter of 2023, the sector growth was recorded at 39.57% (year-on-year), 18.16% points increase from the rate of 21.41% recorded in the same quarter of 2022, and 0.70% points lower than the rate recorded in the preceding quarter. The quarter-on-quarter growth rate recorded in the fourth quarter of 2023 was 17.58%. On an annual basis, the sector grew by 40.79%, higher than 19.00% in 2022. The Information and Communications sector contributed 12.52% to the total Nominal GDP in the 2023 fourth quarter, higher than the rate of 10.42% recorded in the same quarter of 2022 and higher than the 11.57% it contributed in the preceding quarter.

The sector in the fourth quarter of 2023 recorded a growth rate of 6.33% in real terms, year-on-year. From the rate recorded in the corresponding period of 2022, there was a decrease of 4.02% points. On a quarter-on-quarter, the sector exhibited a growth of 16.83% in real terms. On an annual basis, the sector growth stood at 7.91% relative to 9.76% in 2022. Of total real GDP, the sector contributed 16.66% in the 2023 fourth quarter, higher than in the same quarter of the previous year in which it represented 16.22% and higher than the preceding quarter in which it represented 15.97%.




Figure 12: Information and Communication real growth rate

Arts, Entertainment and Recreation

In Nominal terms, the growth of Arts, Entertainment and Recreation sector was 5.41% in the fourth quarter of 2023 (year-on-year), representing a decrease of 0.20% points relative to the preceding quarter's growth rate of 5.61% and a decrease of 17.69% points compared with the year-earlier growth rate of 23.11%. On a quarterly basis, growth was recorded at 17.78%, higher than the quarter-on-quarter growth of Q3 2023 recorded at 6.40%. On an annual basis, the sector grew by 5.31% compared to 18.30% in 2022. The activity contributed 0.14% to the total nominal GDP in the fourth quarter of 2023. This contribution was lower than the 0.15% it contributed in Q4 of 2022 and higher than the 0.13% it contributed in Q3 of 2023.

In real terms, the activity grew by 4.13% year-on-year, which was lower than the rate recorded in Q4 2022 by 3.40% points, and lower by 0.33% points when compared with that of the preceding quarter. Quarter-on-quarter, growth stood at 16.87% in real terms. On an annual basis, the sector grew by 4.28%, slightly lower than 4.29% in 2022. Overall, Art, Entertainment and Recreation contributed 0.21% to real GDP in Q4 2023, relatively the same with the 0.21% recorded in the same quarter of 2022 and higher than the 0.20% recorded in the third quarter of 2023.

Real Estate Services

In nominal terms, Real Estate Services in the fourth quarter of 2023 grew by 2.36%, lower by 8.25% points than the growth rate reported for the same period in 2022 and lower by 0.46% points compared to the preceding Quarter. On a quarter-on-quarter, the sector growth rate was 22.40%. On an annual basis, the sector growth stood at 2.53%, lower than 10.75% in 2022. The contribution to nominal GDP in Q4 2023 stood at 4.95%, relative to 5.62% recorded in the fourth quarter of 2022 and 4.40% in the third quarter of 2023.

Real GDP growth recorded in the sector for the fourth quarter of 2023 stood at 1.34%, lower than the growth recorded in the fourth quarter of 2022 by 1.45% points, and lower by 0.56% points relative to Q3 2023. On a quarter-on-quarter, the sector grew by 21.62% in the fourth quarter of 2023. On an annual basis, the sector growth stood at 1.68%, lower than 3.95% recorded in 2022. It contributed 6.06% to real GDP in Q4 2023, lower than the 6.18% it recorded in the corresponding quarter of 2022.

Finance and Insurance

The Finance and Insurance Sector consists of the two subsectors, Financial Institutions, and Insurance, in which the former accounted for 94.02% and the latter 5.98% of the sector respectively in real terms in Q4 2023.

As a whole, the sector grew at 32.29% in nominal terms (year-on-year), with the growth rate of Financial Institutions at 33.98% and 10.37% growth rate recorded for Insurance. The overall rate was higher than Q4 2022 by 9.71% points, and higher by 2.09% points than the preceding quarter. The quarter-on-quarter growth was 28.62%. On an annual basis, the sector grew by 28.24%, higher than 26.42% in 2022. The sector's contribution to the nominal GDP was 3.76% in Q4 2023, higher than the 3.30% it represented a year previous, and higher than the contribution of 3.17% it made in the preceding quarter.

Growth in this sector in real terms totaled 29.78%, higher by 18.16% points from the rate recorded in the 2022 fourth quarter and higher by 1.56% points from the rate recorded in the preceding quarter. Quarter-on-quarter growth in real terms stood at 27.30%. On an annual basis, the sector grew by 26.53%, higher than 16.36% in 2022. The contribution of Finance and Insurance to real GDP totalled 4.95%, higher than the contribution of 3.95% recorded in the fourth quarter of 2022 by 1.00% points, and higher than 4.36% recorded in Q3 2023 by 0.60% points.




Figure 13: Finance and Insurance real growth

Professional, Scientific and Technical Services

In the fourth quarter of 2023, Professional, Scientific and Technical Services recorded a nominal growth of 3.76% (year-on-year), which is 9.27% points lower than Q4 2022, and 0.03% points higher than the rate recorded in Q3 2023. Quarter-on-quarter, the sector grew by 15.47%. On an annual basis, the sector growth was 3.81% in 2023, lower than 11.14% in 2022. The contribution of Professional, Scientific and Technical Services to nominal GDP was 2.49% in Q4 2023, down from the 2.78% contribution in Q4 2022 and up from the 2.34% recorded in Q3 2023.

Real growth in the sector was recorded at 1.79% in Q4 2023, a decrease of 1.13% points relative to the rate recorded in the corresponding period of 2022, and 0.36% points lower than that of Q3 2023. On a quarter-on-quarter basis, the sector grew by 14.29% in Q4 2023. On an annual basis, the sector growth stood at 2.43% compared to 2.28% in 2022. Professional, Scientific and Technical Services contributed 3.28% to aggregate GDP in Q4 2023, lower than the contribution of 3.34% in Q4 2022 and higher than the 3.22% recorded in Q3 2023.

Administrative and Support Services

In nominal terms, the Administrative and Support Services sector grew by 3.58% (year-on-year) in Q4 2023, lower by 9.39% points compared to the fourth quarter of 2022 and lower by 0.78% points than the growth rate in the previous quarter. Quarter-on-quarter, the growth rate in the sector was -5.86% in Q4 2023. On an annual basis, the sector grew by 2.00%, lower than 12.07% recorded in 2022. The contribution of Administrative and Support Services to nominal GDP was 0.01% in Q4 2023, slightly lower than the 0.02% it contributed in the same period in 2022 and lower than the 0.02% it contributed in the preceding quarter.

In real terms, the sector recorded a growth rate of 1.61% (year-on-year), a decrease of 1.25% points from the corresponding quarter of 2022 and a decrease of 1.16% points from the rate recorded in Q3 2023. Quarter-on-quarter, the sector grew by -6.82% in Q4 2023. On an annual basis, the sector grew by 0.62% in 2023, lower than 3.16% in 2022. The sector's contribution to real GDP was 0.02% in the 2023 fourth quarter, roughly unchanged from the corresponding quarter in 2022 and 2023 third quarter.

Public Administration

In nominal terms, the Public Administration sector grew by 4.16% in Q4 2023, lower by 7.24% points from the corresponding quarter of 2022 and higher by 0.53% points relative to Q3 2023. Quarter-on-quarter, the sector grew by 16.13%. On an annual basis, the sector grew by 3.52%, lower than 10.82% in 2022. The contribution of Public Administration to Nominal GDP stood at 1.59% in Q4 2023, lower than the 1.77% recorded in Q4 2022 by 0.18% points and higher than the 1.49% recorded in Q3 2023 by 0.10% points.

In real terms, the sector recorded a growth rate of 2.18% (year-on-year) in Q4 2023, higher by 0.75% points and higher by 0.13% points from the Q4 2022 rate and the Q3 2023 rate respectively. On a quarter-on-quarter basis, the sector grew by 14.94% in Q4 2023. On an annual basis, the sector grew by 2.12% in 2023 compared to 1.90% in 2022. The contribution of Public Administration to real GDP stood at 2.10% in Q4 2023, lower than the 2.12% recorded in Q4 2022 and higher than the 2.04% in Q3 2023.

Education

Nominal growth in the Education sector in the fourth quarter of 2023 was 3.75% (year-on-year), down by 6.72% points from the growth of 10.47% reported in the corresponding quarter of 2022, and up by 0.26% points when compared to Q3 2023 growth rate of 3.49%. The quarter-on-quarter growth rate was 39.13%. On an annual basis, the sector grew by 3.02%, lower than 7.80% in 2022. The contribution of Education to nominal GDP in Q4 2023 was 1.59%; down from 1.78% estimated in Q4 2022 and up from 1.24% in Q3 2023.

Real growth in Education year-on-year stood at 1.60% in Q4 2023; an increase of 0.36% points from the corresponding quarter of 2022 which was estimated at 1.23%. When compared with the previous quarter's rate of 1.45%, the sector's growth increased by 0.15% points. On an annual basis, the sector grew by 1.31% relative to 1.35% in 2022. The Sector contributed 2.05% to total real GDP in Q4 2023 which was lower than the 2.08% reported for the corresponding quarter in 2022 and higher than the 1.66% recorded in Q3 2023.

Human Health and Social Services

The year-on-year growth rate for Human Health and Social Services in nominal terms was 10.01%, down relative to the growth rate of 14.87% reported in the same quarter of 2022 by 4.86% points and up by 5.67% points compared to Q3 2023. Quarter-on-quarter growth was 5.40%. On an annual basis, the sector grew by 5.24% in nominal terms, lower than 14.31% recorded in 2022. The contribution to nominal GDP was 0.52% in Q4 2023, lower than the 0.54% recorded in Q4 2022 and down from the 0.53% recorded in Q3 2023.

Real GDP growth of Human Health and Social Services for Q4 2023 stood at 3.73% (year-on-year) compared to 4.20% for the corresponding period of 2022 which shows a fall of 0.47% points. The growth in Q4 2023 was higher than the growth recorded in Q3 2023 by 0.81% points. Quarter-on-quarter, this sector grew by 4.70%. On an annual basis, the sector growth stood at 2.78% in real terms, lower than 4.20% in 2022. The contribution of Human Health and Social Services to real GDP was 0.66% in Q4 2023, relatively the same as the figure recorded in Q4 2022 and lower than the 0.71% recorded for the preceding quarter.

Other Services

In nominal terms, Other Services grew by 1.99% (year-on-year) in Q4 2023. This growth rate was lower than the 9.90% growth rate recorded in the same quarter of the previous year and lower than the growth rate of 2.19% in Q3 2023 by 7.90% points and 0.20% points respectively. Quarter-on-quarter growth was 64.00%. On an annual basis, the sector grew by -4.34% in 2023, lower than 9.78% in 2022. This sector contributed 2.40% to the aggregate nominal GDP in Q4 2023, lower than the 2.73% it contributed in the same period of the previous year and higher than the 1.59% it contributed in the preceding quarter.

Other Services' real GDP grew by 0.05% (year-on-year) in Q4 2023. This growth was lower by 0.01% points than the growth recorded in the same period of the previous year, and lower by 0.58% points from Q3 2023. Quarter-on-quarter growth was 62.32%. On an annual basis, the sector grew by -5.68%, lower than 1.07% in 2022. The sector contributed 3.17% to real GDP in Q4 2023, lower than the 3.27% recorded for the corresponding quarter of 2022 and higher than the 2.18% recorded in Q3 2023.
