Preface

This publication provides data on Quarterly Gross Domestic Product (GDP) estimates for the four quarters of 2023, the annual figure for 2023, the first, second and third quarter of 2024.

Quarterly National Accounts (QNA) are integrated systems of macroeconomic accounts designed to describe the entire system of production in a nation quarterly. They provide a picture of the current status of the economy that is timely and more frequent than that provided by Annual National Accounts (ANA). The key attribute of QNA is that they provide a reasonable level of detail of the economy that helps the government to assess, analyse, and monitor economic growth regularly.

QNA adopts the same concepts, definitions, and structure as ANA. In principle, QNA covers the entire sequence of accounts and balance sheets as reflected in the 2008 System of National Accounts (2008 SNA).

Data for this analysis were obtained from the Quarterly Establishment Survey (QES) conducted by the National Bureau of Statistics (NBS). This series covers major aggregates of quarterly GDP by kind of economic activities at current and constant (2010) prices.

We are grateful to the various agencies and establishments that made their data available as input to the estimates.

Introduction

The National Bureau of Statistics (NBS) has been conducting Establishment Surveys to provide data for the estimation of the Gross Domestic Product (GDP) for the country. In 2008, NBS started to improve the GDP series by conducting Quarterly Establishment Surveys (QES) for the four quarters of each year to provide timely estimates for decisions and policymaking.

In 2018, the National Bureau of Statistics (NBS) conducted the Quarterly Establishment Surveys for the first three quarters of 2018 (Q1-Q3/ 2018), while the fourth quarter survey for 2018 was conducted in the first quarter of 2019. This compilation procedure is carried out to date publishing the Q4 GDP report within the first quarter of the new accounting year. It is important to note that the Bureau maintains a publication date of 45 days after the quarter.

In subsequent sections of this report, emphasis will be given to the composition of GDP in the third quarter of 2024, the corresponding quarter of 2023, and the immediate past quarter of 2024 (Q2 2024).



Overview of GDP in Quarter Three 2024

Nigeria's Gross Domestic Product (GDP) grew by **3.46%** (year-on-year) in real terms in the third quarter of 2024. This growth rate is higher than the 2.54% recorded in the third quarter of 2023 and higher than the second quarter of 2024 growth of 3.19%. The performance of the GDP in the third quarter of 2024 was driven mainly by the Services sector, which recorded a growth of 5.19% and contributed 53.58% to the aggregate GDP. The agriculture sector grew by 1.14%, from the growth of 1.30% recorded in the third quarter of 2023. The growth of the industry sector was 2.18%, an improvement from 0.46% recorded in the third quarter of 2023. In terms of share of the GDP, the services sector contributed more to the aggregate GDP in the third quarter of 2024 compared to the corresponding quarter of 2023.

In the quarter under review, aggregate GDP at basic price stood at N71,131,091.07 million in nominal terms. This performance is higher when compared to the third quarter of 2023 which recorded aggregate GDP of N60,658,600.37 million, indicating a year-on-year nominal growth of 17.26%. For better clarity, the Nigerian economy has been classified broadly into the oil and non-oil sectors (Pages 5 & 6).

The Oil Sector

The nation in the third quarter of 2024 recorded an average daily oil production of 1.47 million barrels per day (mbpd), higher than the daily average production of 1.45 mbpd recorded in the same quarter of 2023 by 0.02 mbpd and higher than the second quarter of 2024 production volume of 1.41 mbpd by 0.07mbpd. The real growth of the oil sector was 5.17% (year-on-year) in Q3 2024, indicating an increase of 6.02% points relative to the rate recorded in the corresponding quarter of 2023 (-0.85%). Growth decreased by 4.98% points when compared to Q2 2024 which was 10.15%. On a quarter-on-quarter basis, the oil sector recorded a growth rate of 7.39% in Q3 2024. The Oil sector contributed 5.57% to the total real GDP in Q3 2024, up from the figure recorded in the corresponding period of 2023 and down from the preceding quarter, where it contributed 5.48% and 5.70% respectively.

The Non-Oil Sector

The non-oil sector grew by 3.37% in real terms during the reference quarter (Q3 2024). This rate was higher by 0.62% points compared to the rate recorded in the same quarter of 2023 which was 2.75% and higher than the 2.80% recorded in the second quarter of 2024. This sector was driven in the third quarter of 2024 mainly by Financial and Insurance (Financial Institutions); Information and Communication (Telecommunications); Agriculture (Crop production); Transportation and Storage (Road Transport); Trade; and Construction, accounting for positive GDP growth.

In real terms, the non-oil sector contributed 94.43% to the nation's GDP in the third quarter of 2024, lower than the share recorded in the third quarter of 2023 which was 94.52% and higher than the second quarter of 2024 recorded as 94.30%.

Major Economic Sectors: Q3 2024 Mining & Quarrying

The Mining & Quarrying sector consists of Crude Petroleum and Natural Gas, Coal Mining, Metal ores and Quarrying and Other Minerals sub-activities. This sector grew nominally by 8.75% (year-on-year) in Q3 2024. Metal Ores exhibited the highest growth rate of all the sub-activities at 55.37%, followed by Crude Petroleum and Natural Gas activity at 14.87%. Crude Petroleum and Natural gas was the main contributor to the sector with a weight of 98.00% in Q3 2024. Comparing Q3 2024's rate of growth relative to Q3 2023 and Q2 2024 growth rates, there was a decrease of 23.15% points and an increase of 9.12% points respectively. The Mining & Quarrying sector contributed 7.72% to the overall GDP in the third quarter of 2024, lower than the contributions recorded in 2023 third quarter at 8.32% and higher than the previous quarter at 5.60%.

In real terms, the Mining and Quarrying sector grew by 3.27% (year-on-year) in the third quarter of 2024. Compared to the same quarter of 2023 and the second quarter of 2024, it was higher by 5.23% points and lower by 4.52% points respectively. Quarter- on- quarter, the growth rate recorded was 6.26% during the quarter. The contribution of Mining and Quarrying to Real GDP in the quarter under review stood at 5.63%, lower than the rate of 5.64% recorded in the corresponding quarter of 2023 and lower than the 5.83% recorded in the second quarter of 2024.

Agriculture

Four sub-activities make up the Agricultural sector: Crop Production, Livestock, Forestry and Fishing. The sector grew by 11.29% year-on-year in nominal terms in Q3 2024, showing an increase of 0.23% points from the same quarter of 2023. Looking at the preceding quarter's growth rate of 2.86%, there was an increase of 8.43% points. Crop production remained the major driver of the sector. This is evident as it accounts for 92.28% of the overall nominal value of the sector in the third quarter of 2024.

Quarter-on-quarter growth stood at 57.53% in the third quarter of 2024. Agriculture contributed 25.01% to nominal GDP in the third quarter of 2024. This figure was lower than the rate recorded in the third quarter of 2023 and higher than the second quarter of 2024 which recorded 26.36% and 18.54% respectively.

The agricultural sector in the third quarter of 2024 grew by 1.14% (year-on-year) in real terms, a decrease of 0.15% points from the corresponding period of 2023, and a decrease of 0.27% points from the preceding quarter which recorded a growth rate of 1.41%. It grew on a quarter-on-quarter basis at 39.38%.

However, the sector contributed 28.65% to overall GDP in real terms in Q3 2024, lower than the contribution in the third quarter of 2023 and higher than the second quarter of 2024 which stood at 29.31% and 22.61% respectively.

Manufacturing

The Manufacturing sector is comprised of thirteen activities: Oil Refining; Cement; Food, Beverages and Tobacco; Textile, Apparel, and Footwear; Wood and Wood products; Pulp Paper and Paper products; Chemical and Pharmaceutical products; Non-metallic Products, Plastic and Rubber products; Electrical and Electronic; Basic Metal and Iron and Steel; Motor Vehicles and Assembly; and Other Manufacturing.

Nominal GDP growth of the Manufacturing sector in the third quarter of 2024 was recorded at 3.62% (year-on-year), 32.97% points lower than the figure recorded in the corresponding period of 2023 (36.59%) and 1.72% points higher than the preceding quarter figure of 1.91%. Quarter-on- quarter, growth of the sector was recorded at 31.67% during the quarter. The contribution of Manufacturing to Nominal GDP in the third quarter of 2024 was 14.30%, lower than the figure recorded in the corresponding period of 2023 at 16.18% and higher than the second quarter of 2024 at 12.68%.

Real GDP growth in the manufacturing sector in the third quarter of 2024 was 0.92% (year-on-year), higher than the same quarter of 2023 and lower than the preceding quarter by 0.44% points and 0.35% points respectively. The growth rate of the sector on a quarter-on-quarter basis stood at 6.74%. The Real contribution to GDP in the 2024 third quarter was 8.21%, lower than the 8.42% recorded in the third quarter of 2023 and lower than the 8.46% recorded in the second quarter of 2024.

Electricity, Gas, Steam and Air Conditioning Supply

The Electricity, Gas, Steam and Air conditioning Supply sector recorded a year-on-year growth of 5.23% in the third quarter of 2024. This was 30.78% points lower than the 36.01% growth rate recorded in the corresponding quarter of 2023, and 2.42% points lower than the growth rate of 7.65% recorded in the quarter before. Quarter–on-quarter, the sector recorded a growth rate of -43.65% in Q3 2024. The contribution of Electricity, Gas, Steam and Air Conditioning Supply to Nominal GDP in the third quarter of 2024 was 0.75%, lower than the contribution made in the corresponding quarter of 2023 at 0.84% and lower than its contribution of 1.56% in the quarter before.

In real terms, the sector grew by 3.23% in Q3 2024, an increase from the growth rate of 1.91% recorded in the same quarter of 2023. When compared to the immediate past quarter, there was a decrease of 2.73% points from 5.96% recorded. On a quarter-on-quarter, the sector grew at a rate of -43.93%. The contribution of this sector to real GDP in the third quarter of 2024 was 0.37%, relatively same with the 0.37% recorded in Q3 2023 and lower than the 0.73% recorded in Q2 2024.

Water Supply, Sewerage, Waste Management and Remediation

This sector grew by 12.73% in nominal terms (year-on-year) in the third quarter of 2024, a decrease of 13.16% points compared to the rate of 25.88% recorded in the same quarter of 2023. There was an increase of 2.14% points when compared to the rate recorded in the preceding quarter. Nominal growth quarter-on-quarter was recorded at -45.37%. The Water Supply, Sewerage, Waste Management and Remediation sector contributed 0.32% to nominal GDP in the third quarter of 2024, lower than the 0.33% it contributed a year earlier and lower than the 0.68% contributed in the second quarter of 2024.

The real growth rate of the Water Supply, Sewerage, Waste Management and Remediation sector in the third quarter of 2024 was recorded at 9.78% (year-on-year), lower by 2.16% points from the rate recorded in the previous year. Relative to the preceding quarter, there was an increase of 1.57% points. Quarter-on-quarter, the sector grew by -45.74% in real terms.

Its contribution to total real GDP was 0.22% in the third quarter of 2024, slightly higher than its contribution of 0.20% in the same quarter of the previous year, and lower than the immediate past quarter where it contributed 0.44%.

Construction

The Construction sector grew by 4.19% in nominal terms (year-on-year) in the 2024 third quarter, an increase of 1.17% points compared to the rate of 3.02% recorded in the same quarter of 2023. Also, there was an increase of 2.20% points when compared to the rate recorded in the preceding quarter. Nominal growth quarter-on-quarter was recorded at 3.48%. Construction contributed 7.49% to nominal GDP in the third quarter of 2024, lower than the 8.43% it contributed a year earlier and lower than the 8.45% contributed to the second quarter of 2024.

The real growth rate of the construction sector in the third quarter of 2024 was recorded at 2.91% (year-on-year), lower by 0.97% points from the rate recorded in the previous year. Relative to the preceding quarter, there was an increase of 1.87% points. Quarter-on-quarter, the sector grew by 16.20% in real terms.

Its contribution to total real GDP was 3.35% in the third quarter of 2024; lower than its contribution of 3.36% in the same quarter of the previous year, and higher than in the immediate past quarter where it contributed 3.17%.

Trade

In the third quarter of 2024, the nominal year-on-year growth rate of Trade stood at 34.27%. This indicates an increase of 31.17% points when compared to the third quarter of 2023 growth rate of 3.10% and 11.62% points lower than the previous quarter's growth rate of 45.89%. The quarter-on-quarter growth rate was -7.31%. Trade's contribution to Nominal GDP in the third quarter of 2024 was 12.67%, higher than the contribution in the same quarter of the previous year of 11.06%, and lower than the preceding quarter recorded at 15.95%.

In real terms, Trade's year-on-year growth stood at 0.65% in the third quarter of 2024, which was 0.88% points lower than the rate recorded in the previous year at 1.53%, and 0.05% points lower than in the preceding quarter at 0.70% growth rate. Quarter-on-quarter growth stood at -0.79%. This growth was lower than the quarter-on-quarter growth recorded in the second quarter of 2024 at 4.42%. Trade's contribution to GDP was 14.78%, lower than the 15.19% it represented in the previous year, and lower than the 16.39% recorded in the second quarter of 2024.

Accommodation and Food Services

In nominal terms, Accommodation and Food Services grew by 8.78% year -on- year in 2024 third quarter. This represents an increase of 1.76% points relative to the same quarter of 2023 when the growth rate was 7.02%. Growth was higher than in the preceding quarter by 5.79% points when growth was 2.99%. Quarter-on-quarter growth stood at 112.50%. Accommodation and Food Services contribution to nominal GDP stood at 0.77% in the third quarter of 2024, lower than the figure recorded in the previous year and higher than the second quarter of 2024 contribution recorded at 0.83% and 0.42% respectively.

The real year-on-year growth rate for this sector in the third quarter of 2024 stood at 4.44%, higher by 0.87% points from 3.57% recorded in the previous year. Relative to the preceding quarter, the growth rate was 2.31% points higher than the 2.13% recorded. Quarter-on-quarter, real growth was 103.88%. The sector in the third quarter of 2024 represented 0.73% of the real GDP, which was slightly higher with the contribution of 0.72% recorded in the third quarter of 2023 and higher than the second quarter of 2024 contribution of 0.39%.

Transportation and Storage

Six activities make up the Transportation and Storage sector: Road Transport; Rail Transport and Pipelines; Water Transport; Air Transport; Transport Services; and Post and Courier Services.

The sector grew by 28.70% in nominal terms in the third quarter of 2024 (year-on-year). This rate was higher relative to the figure of -28.57% recorded for the corresponding quarter of 2023 and higher than -9.08% in the previous quarter. All six sub-activities under the Transport and Storage industry recorded positive growth rates in the third quarter of 2024. Quarter-on-quarter growth stood at 42.02%. Transport activities contributed 1.27% to Nominal GDP in Q3 2024, an increase from the 1.16% recorded in the corresponding period of 2023, and higher than the 1.05% recorded in the second quarter of 2024.

In real terms, the Transportation and Storage sector grew by 12.15% in Q3 2024. This rate represents an increase of 47.99% points compared to the same quarter of the previous year and an increase of 25.68% points relative to the preceding quarter. Quarter-on-quarter, growth was 35.07%. The contribution of the sector to real GDP in Q3 of 2024 was 0.91%, higher than the 0.84% recorded in the preceding year and higher than 0.74% recorded in the second quarter of 2024.

Information & Communication

The Information and Communication sector is composed of the four activities of Telecommunications and Information Services; Publishing; Motion Picture, Sound Recording and Music Production; and Broadcasting.

In nominal terms, in the third quarter of 2024, the sector growth was recorded at 14.51% (year-onyear), 25.75% points decrease from the rate of 40.27% recorded in the same quarter of 2023, and 2.65% points higher than the rate recorded in the preceding quarter. The quarter-on- quarter growth rate recorded in the third quarter of 2024 was -7.01%. The Information and Communications sector contributed 11.30% to the total Nominal GDP in the third quarter of 2024, lower than the rate of 11.57% recorded in the same quarter of 2023 and lower than the 14.19% it contributed in the preceding quarter.

The sector in the third quarter of 2024 recorded a growth rate of 5.92% in real terms, year-on-year. From the rate recorded in the corresponding period of 2023, there was a decrease of 0.77% points. On a quarter-on-quarter, the sector exhibited a growth of -9.02% in real terms. Of total real GDP, the sector contributed 16.35% in the third quarter of 2024, higher than in the same quarter of the previous year in which it represented 15.97% and lower than the preceding quarter in which it represented 19.78%.

Arts, Entertainment and Recreation

In Nominal terms, the growth of Arts, Entertainment and Recreation sector was 61.07% in the third quarter of 2024 (year-on-year), representing an increase of 15.12% points relative to the preceding quarter's growth rate of 45.95% and a rise of 55.46% points compared with the year-earlier growth rate of 5.61%. On a quarterly basis, growth was recorded at 17.42%, higher than the quarter-on-quarter growth of Q2 2024 recorded at -23.69%. The activity contributed 0.18% to the total nominal GDP in the third quarter of 2024. This contribution was higher than the 0.13% it contributed in Q3 of 2023 and same with the 0.18% it contributed in Q2 of 2024.

In real terms, the activity grew by 4.74% year-on-year, which was higher than the rate recorded in Q3 2023 by 0.29% points, and higher by 2.95% points when compared with that of the preceding quarter. Quarter-on-quarter, growth stood at 8.31% in real terms. The activity of Art, Entertainment and Recreation contributed 0.20% to real GDP in Q3 2024, relatively same with the 0.20% recorded in the same quarter of 2023 and the 0.20% recorded in the second quarter of 2024.

Real Estate Services

In nominal terms, Real Estate Services in the third quarter of 2024 grew by 46.52%, higher by 43.70% points than the growth rate reported for the same period in 2023 and lower compared to the preceding Quarter. On a quarter-on-quarter, the sector growth rate was 16.15%. The contribution to nominal GDP in Q3 2024 stood at 5.49%, relative to 4.40% recorded in the third quarter of 2023 and 5.52% in the second quarter of 2024.

Real GDP growth recorded in the sector for the third quarter of 2024 stood at 0.68%, lower than the growth recorded in the third quarter of 2023 by 1.21% points, and lower by 0.07% points relative to Q2 2024. On a quarter-on-quarter, the sector grew by 15.54% in the third quarter of 2024. It contributed 5.43% to real GDP in Q3 2024, lower than the 5.58% it recorded in the corresponding quarter of 2023.

Finance and Insurance

The Finance and Insurance Sector consists of the two subsectors, Financial Institutions, and Insurance, in which the former accounted for 91.76% and the latter 8.24% of the sector respectively in real terms in Q3 2024.

Overall, the sector grew at 74.54% in nominal terms (year-on-year), with the growth rate of Financial Institutions at 75.99% and 59.84% growth rate recorded for Insurance. The overall rate was higher than Q3 2023 by 44.34% points, and lower by 12.05% points than the preceding quarter. The quarter-on-quarter growth was -13.80%. The sector's contribution to the nominal GDP was 4.72% in Q3 2024, higher than the 3.17% it represented a year previous, and lower than the contribution of 6.39% it made in the preceding quarter.

Growth in this sector in real terms totaled 30.83%, higher by 2.62% points from the rate recorded in the 2023 third quarter and higher by 2.04% points from the rate recorded in the preceding quarter. Quarter-on-quarter growth in real terms stood at -7.73%. The contribution of Finance and Insurance to real GDP totalled 5.51%, higher than the contribution of 4.36% recorded in the third quarter of 2023 by 1.15% points, and lower than 6.57% recorded in Q2 2024 by 1.06% points.

Professional, Scientific and Technical Services

In the third quarter of 2024, Professional, Scientific and Technical Services recorded a nominal growth of 35.22% (year-on-year), which is 31.48% points higher than Q3 2023, and 11.59% points lower than the rate recorded in Q2 2024. Quarter-on-quarter, the sector grew by 7.95%. The contribution of Professional, Scientific and Technical Services to nominal GDP was 2.70% in Q3 2024, up from the 2.34% contribution in Q3 2023 and down from the 2.92% recorded in Q2 2024.

Real growth in the sector was recorded at 1.36% in Q3 2024, a decrease of 0.80% points relative to the rate recorded in the corresponding period of 2023, and 0.02% points higher than that of Q2 2024. On a quarter-on-quarter basis, the sector grew by 15.55% in Q3 2024. Professional, Scientific and Technical Services contributed 3.15% to aggregate GDP in Q3 2024, lower than the contribution of 3.22% in Q3 2023 and higher than the 3.00% recorded in Q2 2024.

Administrative and Support Services

In nominal terms, the Administrative and Support Services sector grew by 36.61% (year-on-year) in Q3 2024, higher by 32.25% points compared to the third quarter of 2023 and lower by 10.18% points than the growth rate in the previous quarter. Quarter-on-quarter, the growth rate in the sector was 13.72% in Q3 2024. The contribution of Administrative and Support Services to nominal GDP was 0.02% in Q3 2024, relatively same with the 0.02% it contributed in the same period in 2023 and the figure of 0.02% it contributed in the preceding quarter.

In real terms, the sector recorded a growth rate of 2.40% (year-on-year), a decrease of 0.37% points from the corresponding quarter of 2023 and an increase of 1.08% points from the rate recorded in Q2 2024. Quarter–on-quarter, the sector grew by 21.72% in Q3 2024. The sector's contribution to real GDP was 0.02% in the 2024 third quarter, roughly unchanged from the corresponding quarter in 2023 and 2024 second quarter.

Public Administration

In nominal terms, the Public Administration sector grew by 36.79% in Q3 2024, higher by 33.16% points from the corresponding quarter of 2023 and lower by 10.76% points relative to Q2 2024. Quarter-onquarter, the sector grew by -2.66%. The contribution of Public Administration to Nominal GDP stood at 1.73% in Q3 2024, higher than the 1.49% recorded in Q3 2023 by 0.25% points and lower than the 2.08% recorded in Q2 2024 by 0.35% points.

In real terms, the sector recorded a growth rate of 2.53% (year-on-year) in Q3 2024, higher by 0.48% points and higher by 0.69% points from the Q3 2023 rate and the Q2 2024 rate respectively. On a quarter-on-quarter basis, the sector grew by 4.19% in Q3 2024. The contribution of Public Administration to real GDP stood at 2.02% in Q3 2024, lower than the 2.04% recorded in Q3 2023 and lower than the 2.14% in Q2 2024.

Education

Nominal growth in the Education sector in the third quarter of 2024 was 9.88% (year-on-year), up by 6.40% points from the growth of 3.49% reported in the corresponding quarter of 2023, and up by 3.57% points when compared to Q2 2024 growth rate of 6.31%. The quarter-on-quarter growth rate was 43.02%. The contribution of Education to nominal GDP in Q3 2024 was 1.17%; down from 1.24% reported in Q3 2023 and up from 0.95% in Q2 2024.

Real growth in Education year-on-year stood at 2.29% in Q3 2024; an increase of 0.84% points from the corresponding quarter of 2023 which was estimated at 1.45%. When compared with the previous quarter's rate of 1.92%, the sector's growth increased by 0.37% points. The Sector contributed 1.64% to total real GDP in Q3 2024 which was lower than the 1.66% reported for the corresponding quarter in 2023 and higher than the 1.31% recorded in Q2 2024.

Human Health and Social Services

The year-on-year growth rate for Human Health and Social Services in nominal terms was 13.34%, up relative to the growth rate of 4.34% reported in the same quarter of 2023 by 9.00% points and up by 2.09% points compared to Q2 2024. Quarter-on-quarter growth was 5.77%. The contribution to nominal GDP was 0.51% in Q3 2024, lower than the 0.53% recorded in Q3 2023 and down from the 0.57% recorded in Q2 2024.

Real GDP growth of Human Health and Social Services for Q3 2024 stood at 3.26% (year-on-year) compared to 2.93% for the corresponding period of 2023 which shows an increase of 0.33% points. The growth in Q3 2024 was higher than the growth recorded in Q2 2024 by 0.85% points. Quarter-on-quarter, this sector grew by 3.71%. The contribution of Human Health and Social Services to real GDP was 0.71% in Q3 2024, relatively same with the figure recorded in Q3 2023 and lower than the 0.75% recorded in the preceding quarter.

Other Services

In nominal terms, Other Services grew by 37.64% (year-on-year) in Q3 2024. This growth rate was higher than the 2.19% growth rate recorded in the same quarter of the previous year and higher than the growth rate of 26.54% in Q2 2024 by 35.45% points and 11.10% points respectively. Quarter-on-quarter growth was -2.74%. This sector contributed 1.87% to the aggregate nominal GDP in Q3 2024, higher than the 1.59% it contributed in the same period of the previous year and lower than the 2.24% it contributed in the preceding quarter.

Other Services' real GDP grew by 0.47% (year-on-year) in Q3 2024. This growth was lower by 0.16% points than the growth recorded in the same period of the previous year, and higher by 13.13% points from Q2 2024. Quarter-on-quarter growth was 1.38%. The sector contributed 2.12% to real GDP in Q3 2024, lower than the 2.18% recorded for the corresponding quarter of 2023 and lower than the 2.30% recorded in Q2 2024.
